


RCPS Strategic Plan Priority Area 1: Teaching and Learning

Goal #1: Teaching and Learning for Literacy: Provide and align common instructional practices that will accommodate the learning of *all students* including all marginalized groups and allow greater achievement of proficiency.

SPECIFIC: Professionals will continue to refine the agreed upon curriculum by establishing consistent expectations for reading, writing, and word work using the CCSS and aligned materials. Ensure that the assessment plan in place is comprehensive and addresses critical literacy components, as well as classroom instruction, to support instructional decision-making.

MEASURE: Increase VTCAP scores for students in grades 3-6 and increase local assessment measures for all students.

ATTAINABLE: As a school, there will be an average increase of 10% in the number of students making progress as measured by VTCAP.

REALISTIC: Based on our current professional evaluation plan and access to resources, we believe this to be a realistic goal. Teachers will receive ongoing support with literacy through resources, professional development opportunities, and access to District Literacy Coach.

TIME BOUND: by the end of fiscal year 2026.

Goal # 2: Teaching and Learning for Math: Provide and align instructional timeline that aligns skills with prioritized grade level standards to improve teacher efficacy and student learning outcomes.

SPECIFIC: Professionals will create an instructional guide that specifies timelines prioritizing instructional strategies and practices that align with current content.

MEASURE: Increase of VTCAP scores, increase student outcomes on local measures.

ATTAINABLE: As a school, there will be an average increase of 10% in the number of students making progress with the goal of meeting proficiency.

REALISTIC: Based on the current PD plan and access to various resources, this is a realistic goal.

TIMEBOUND: by the end of the 2026-2027 fiscal year

Goal #3: To improve the overall well-being of students including physical, social, and emotional health.

SPECIFIC: Educators will learn how to integrate social and emotional learning into their daily practices to improve student behaviors, develop strategies for students for students to self-regulate, and learn to make healthy decisions.

MEASURE: There will be a 10% decrease in behavioral referrals. (There were 690 total incidents as of 5/17/2024.) Family surveys related to safety and comfort. Social and emotional, pre and post-assessment for students. Increase opportunities mentoring at the building based level.


ATTAINABLE: As a school, there will be an average decrease of 10% in the number of students with behavioral referrals with 2 or more referrals.

REALISTIC: Our counselors provide social emotional learning once a week in all grade levels. Counselors provide small group social skills on a rotating basis. We implement Community Block daily for our class community.

TIME BOUND: The goal is to see a decrease of 10% by the end of the June 2026.


Students at RIS respect each other's differences
