WORK-STUDY SESSION

John Compton from **Baker Tilly Virchow Krause, LLP** reviewed the single financial audit, for the year ending June 30, 2018, with directors prior to the meeting. During the review, Mr. Compton stated their report included an unmodified opinion that the financial statements present fairly, in all material respects, the respective financial position of CSIU funds. He indicated reports will be filed with both state and federal agencies prior to the March 31 deadline. Mr. Compton commended CSIU staff for their professionalism and cooperation during the audit process.

SPOTLIGHT SEGMENT

CSIU Safety and Security Consultants, **Leo Sokoloski** and **James Murtin**, provided the Directors with an update on initiatives in the CSIU districts. They discussed their services which include conducting risk and vulnerability assessments, assisting in hiring personnel, hosting job-alike groups and advising district personnel on best practices for improving school security. There has been no cost to the districts for these services.

BUDGET AND FINANCE MATTERS

CSIU directors accepted monthly financial reports and approved payment requests for February. Directors also approved the Single Audit for year ending June 30, 2018; school bus drivers for the CSIU's student transportation programs; a lease agreement amendment with 275 Grandview, LLC; an equipment lease renewal with Pitney Bowes; the opening of a money market account with FNB Corporation; and revisions to plan documents for the CSIU's tax deferred annuity programs.

TECHNOLOGY/MARKETPLACE MATTERS

Directors approved definite quantity line-item bid awards for the Keystone Purchasing Network (KPN), which included art supplies, general supplies, computer supplies and copy paper.
