INGREDIENT INFORMATION

Ingredients: Cooked Natural Proportion Chicken with Natural Juices (Chicken Meat, Salt).

Recommended Preparation Instruction:

BEST METHOD - CONVENTIONAL OVEN (THAWED):

1. PREHEAT CONVENTIONAL OVEN TO 350°F.
2. REMOVE CONTENTS OF BAG INCLUDING JUICES INTO A HOTEL PAN.
3. COVER WITH FOIL AND BAKE FOR 20 MINUTES OR UNTIL 165°F.
4. SHRED APART WITH TONGS.
5. LET STAND COVERED FOR 10 MINUTES BEFORE SERVING.

ALTERNATE METHOD STEAM (THAWED):

1. PLACE SEALED BAGS IN A PERFORATED PAN.
2. STEAM FOR 20 MINUTES OR UNTIL 165°F.
3. REMOVE FROM STEAM AND EMPTY CONTENTS OF BAG INCLUDING JUICES INTO A HOTEL PAN.
4. SHRED APART WITH TONGS.
5. LET STAND FOR 10 MINUTES BEFORE SERVING.
