# **Recommended Preparation Instruction:**

#### **BEST METHOD - CONVENTIONAL OVEN (THAWED):**

- 1. PREHEAT CONVENTIONAL OVEN TO 350°F.
- REMOVE CONTENTS OF BAG INCLUDING JUICES INTO A HOTEL PAN.
- COVER WITH FOIL AND BAKE FOR 20 MINUTES OR UNTIL 165°F.
- 4. SHRED APART WITH TONGS.
- LET STAND COVERED FOR 10 MINUTES BEFORE SERVING.

#### **ALTERNATE METHOD STEAM (THAWED):**

- 1. PLACE SEALED BAGS IN A PERFORATED PAN.
- 2. STEAM FOR 20 MINUTES OR UNTIL 165°F.
- REMOVE FROM STEAM AND EMPTY CONTENTS OF BAG INCLUDING JUICES INTO A HOTEL PAN.
- 4. SHRED APART WITH TONGS.
- 5. LET STAND FOR 10 MINUTES BEFORE SERVING.
