New Business:

- 1. Review and update the Bylaws of CCS Athletic Booster Club The offices voted and agreed to change the following bylaws:
- Article 3: Section 2 and 4 removed. Section 3 will now become section 2.
- Article 4, Section 1: Qualification for officers revised to state any member with a student athlete the current academic year, who is in good standing is eligible to serve as an Officer of the Club. Statement was also added that no officer shall be a coach, assistant coach, or a spouse thereof.
- Article 4, Section 4: Added that nominations will be held in April and voting will take place at the last meeting in May. Sentence was also added that elected officers maybe dismissed at the discretion of AD and administration with probable cause. Add sending donation thank you letters to Secretary responsibilities.
- -Article 4 Section 4: Added the position of Past President under the list of officers. The description/responsibilities of the Past President will be to act as an advisor to the newly elected President and other officers regarding past practices and operations in accordance with Athletic Booster Club bylaws. The Past President will serve for a period of six month when there is a new President elected into office. The Past President will not have voting privileges during Booster Club offices meetings.
- Article 4, Section 5: Each elected officer shall serve until re-elected or until a successor has been duly elected or appointed. (Vacated position will be appointed at the discretion of the AD/Administration)
- Article Five, Section 1: Fiscal year was changed to July June to coincide with the school's fiscal year
- Article 6, Section 4: Removed

- Once Robin Staton updates the bylaws and are approved, they will be added to booster club section of the school website.
