Crestview Elementary Standard Mode of Dress Requirements 2017-2018

SHIRTS: SOLID COLORS ONLY

- Solid Color Button Down or Solid Color Polo-style. (Sleeves at least 3" in length) **T-Shirts are not permitted.**
- LOGO – If a logo is worn, the logo needs to be less than the size of a quarter.
- Shirts may have long or short sleeves (turtlenecks or t-shirts may be worn underneath SMOD shirts only). • Spirit shirts can only be worn on days announced.

PANTS/SHORTS/SKIRTS: SOLID COLORS ONLY (Navy, Khaki, Black, White) NO BLUE JEANS except on spirit days, when announced.

- Dockers style or **Capri**. SOLID COLORS ONLY – Navy, Khaki, Black, or White in appropriate sizes worn at waist level. No sagging will be allowed. Pants may not be frayed nor touch the ground.
- Shorts are allowed and must be no higher than the top of knee and always worn at the waist.
- No cargo pants/cargo shorts will be allowed. No denim of any color, stretch material, spandex type corduroy or nylon.
- Skirt length must be at the top of the knee when standing. Shorts must be worn underneath. (No frayed edges or slits).
- Leggings can be worn under skirts/dress but must be a solid color. • Pant legs are not to be tucked in to socks.
- Skorts (combination skirts/shorts) are allowed. Skorts must be no higher than the top of knee.
- Jumpers are acceptable over a SMOD shirt. Jumpers must also be Navy or Khaki (no denim or blue jean material is allowed).

SWEATERS/SWEATSHIRTS: SOLID COLORS ONLY – NO LOGOS

A student may wear a sweater or sweatshirt in SOLID COLORS. HOODIES: may be worn to school but the hood portion must be down off the head. Collars of SMOD shirts (worn underneath) must be seen at all times.

JACKETS/COATS:

Jackets are not worn in the building. If a jacket has a hood attached, it must be worn down – off the head.

Hair:

Hair must be a natural color. Haircuts which are unusual or bizarre such as mohawks, lines, words, and numbers, will not be allowed. **Designs cut into the hair are not allowed.**

Shoes:

Tennis Shoes are Preferred. Shoes must have a back or heel strap. Shower shoes, flip flops, or house shoes are not allowed.

Other Items:

Hats, caps, do-rags, hair scarves, sweatbands and bandanas are not allowed on campus at any time.

All dress code concerns will be at the discretion of campus administration.
