Mission Statement

The mission of the Tri-Valley Endowment Fund is to encourage charitable giving and provide on-going management of those funds to support quality academic events for the district and its communities, and post secondary education scholarships for Tri-Valley graduates.

Purpose

- ◆ To engage our communities in our quality education system,
- ◆ To encourage individuals, businesses, organizations, and private foundations to give charitably to Tri-Valley Schools,
- ◆ To effectively manage endowment funds to assure on-going preservation and growth of the mission,
- ◆ To provide service and financial support for academic projects and events, and
- ◆ To provide scholarships to benefit students, staff and alumni within the Tri-Valley School District.

Contributions

The intent of the funds is to use the income generated from our investment for scholarships and academic events or projects that will enhance the educational system. This will, in turn, promote leadership and development in our staff, and engage our communities.

Contributions to the Endowment Fund may be made in the following ways:

- ◆ Support of events specifically designated for the Endowment Fund
- ◆ An outright gift in cash or long-term appreciated securities
- ◆ A memorial gift of cash or assets in memory of a friend, family, or staff
- ◆ A deferred gift such as bequests, gift annuities, life insurance, charitable remainder trusts
- ◆ Endowed scholarships in the family or organization name

Governance

The Tri-Valley Schools Endowment Fund was established and adopted by the Board of Education in August 1995. An eight-member board of Trustees has been appointed to manage the Endowment. The Trustees work with the Board of Education and the Superintendent and have broad authority relative to all aspects of the operation of the Endowment.

The Tri-Valley Schools are strictly governed by the Laws of the State of Ohio. All fund disbursements are subject to audit and must conform to strict audit requirements. A Tri-Valley Endowment Fund account for designated scholarship funds is maintained by Century National Bank Investment Services. All investment practices for this account follow the State of Ohio rules for investment of public funds.
