Holy Trinity Annex has taken over the facility, which is probably why your records indicate an enrollment. In the next submission, budgetary numbers will be allocated. The items that were purchased for St. Peter's were returned to the district shortly after the facility closed, so no claim was submitted for them. **The intent is to return the previous St. Peter's allocations to the "general budget" and then work with the Holy Triniyy Annex administration to allocate and budget appropriate funds for those students.**

As stated in previous submissions, Millenial Kingdom and Ridge School did not return calls when surveyed.

Due to COVID, the district 1:1 device plan for students expanded from grades 6-12, to k-12 during the last two years. Regardless of the pandemic duration, the school community sees value in continuing with a k-12 1:1 device plan. This has increased our yearly replacement cycle from 500 devices to 1000 devices in order to keep all units current and updated.

Due to enrollment decreases, we were able to reduce the number of interactive whiteboard purchased by 4 units. This is reflected in the cost savings indicated below. At this time, all instructional spaces are outfitted with an interactive screen.

Accordingly, all remaining SSBA funds [both unbudgeted and previously budgeted but unspent, from High Tech Security and Network Connectivity] are being allocated to the purchase of laptop computers.

**A future plan will be submitted for the purchase of additional chromebooks.**

The district network infrastructure is robust and exceeds the minimum requirements for wireless connectivity as described by the State.

Our High Tech Security project is also complete and came in under-budget; reallocation of these funds to Classroom Learning Technology is most prudent.

Similarly, every instructional space in the district has an interactive screen in place, and district funds have been allocated for replacements as needed, thus these funds are better allocated to the purchase of 1:1 devices for students. Cost savings from the original SSBA request to the actual purchasing of interactive whiteboards resulted in unspent funds in this category that are better used towards the purchase of chromebooks.

With the essential infrastructure in place and key classroom learning technology in place, the financial driver for the district at this time is maintaining our 1:1 device initiative for students. We have a 4 year replacement cycle in place, and the use of our remaining SSBA allocation for the purchase of 1:1 devices is essential to the long-term viability of this program.
