

2011 Peak to Peak Annual Survey Results

Response Statistics

- 378 families completed the survey for 533 students
- Of the 378 families, 135 (36%) had more than one child
243 (64%) had one child
- 160 elementary students/446 in school = 36%
- 152 middle school students/404 in school = 38%
- 221 high school students/574 in school = 39%
- 533 students/1426 students at Peak to Peak = 37.4%
- 378/~940 families = 40.2%

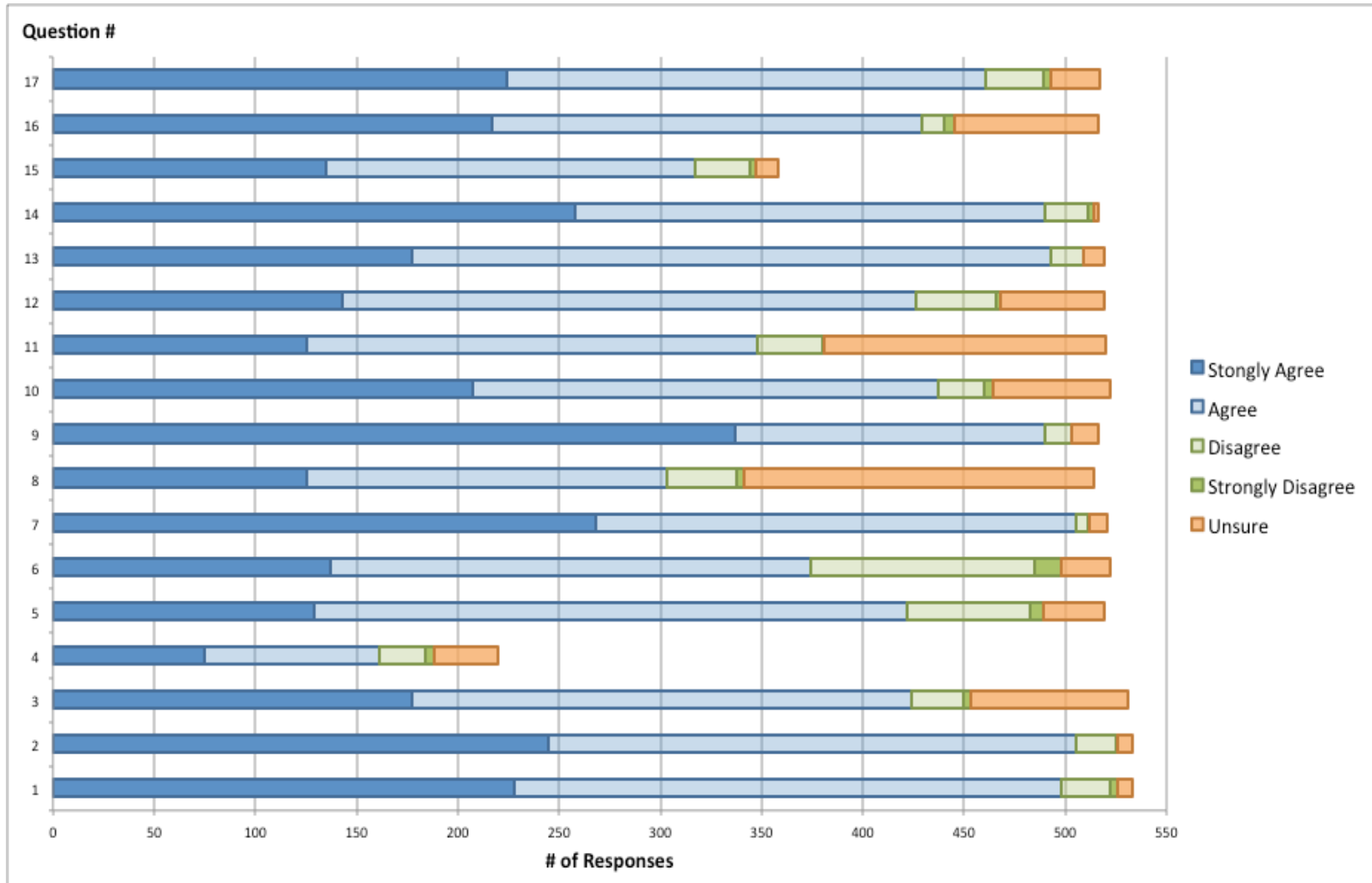

 Elementary, Middle School, and High School Combined



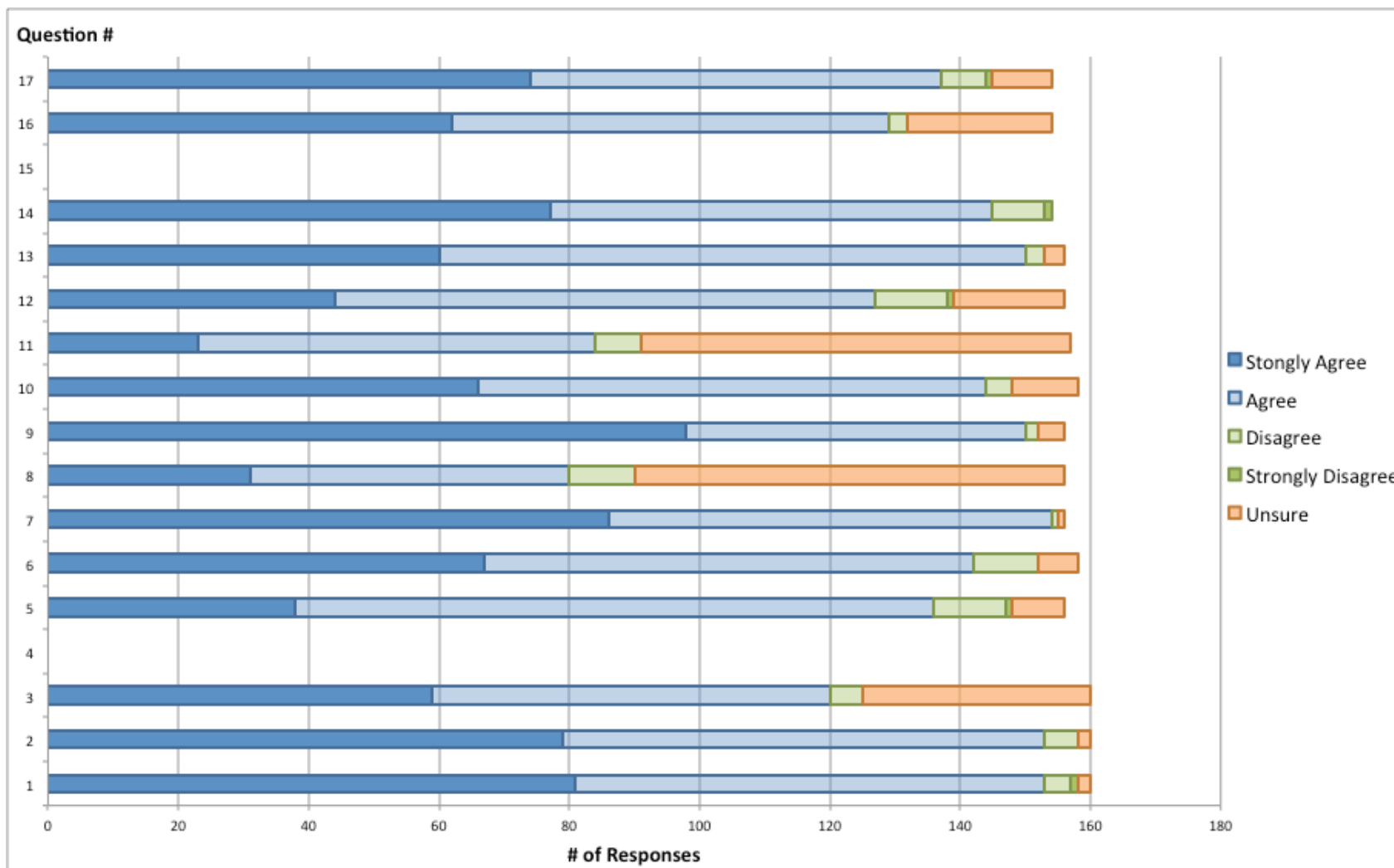

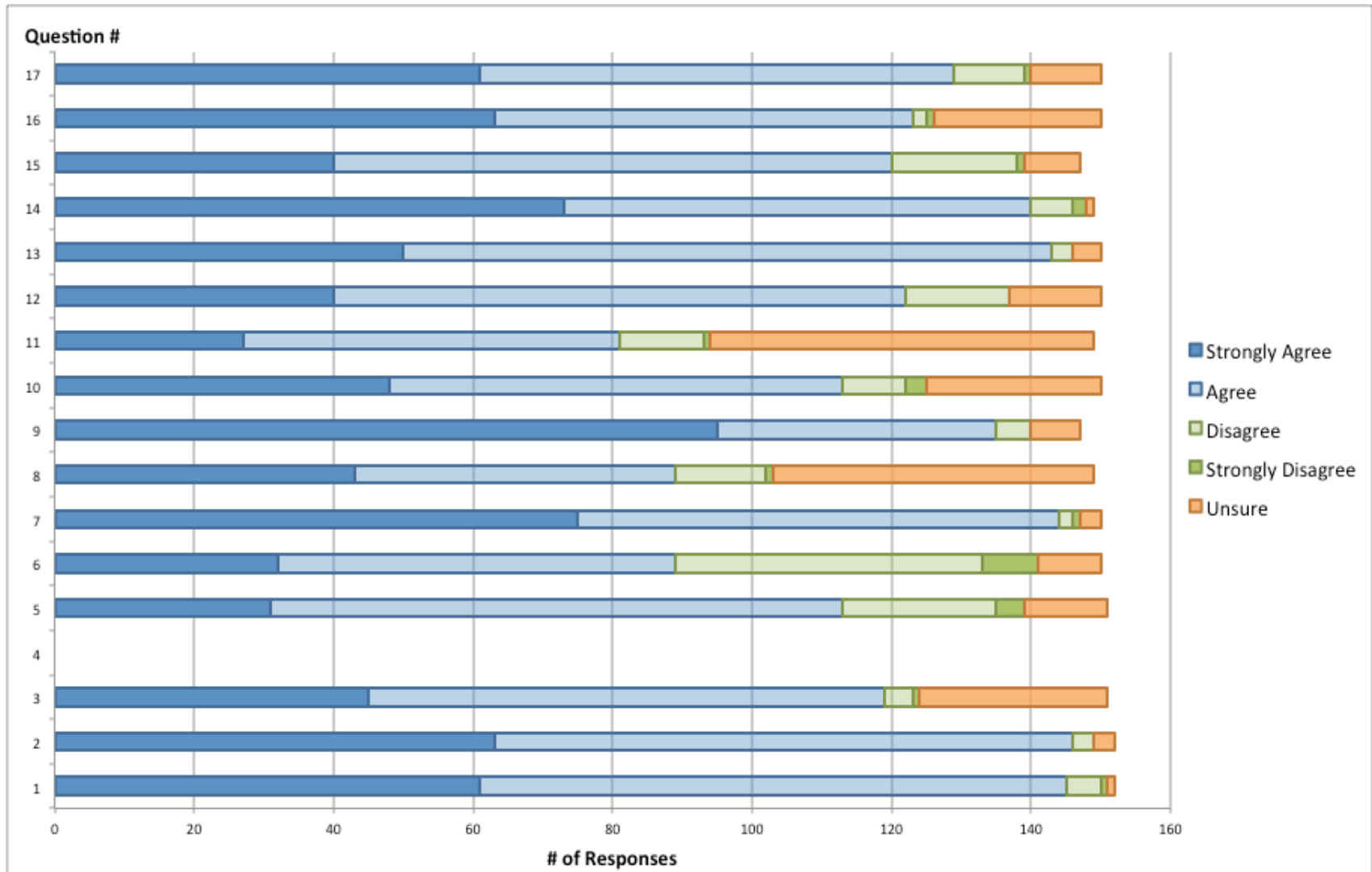

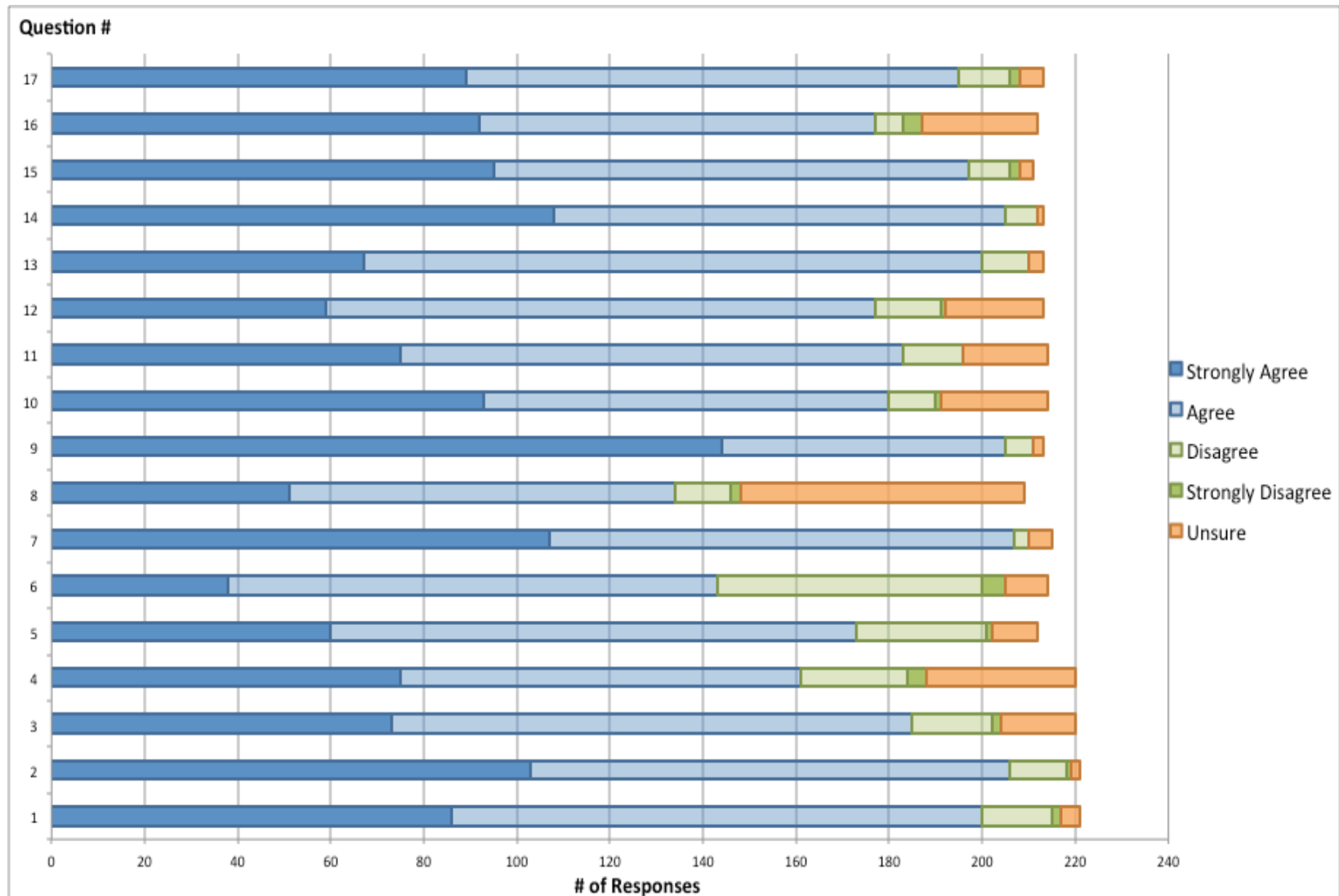

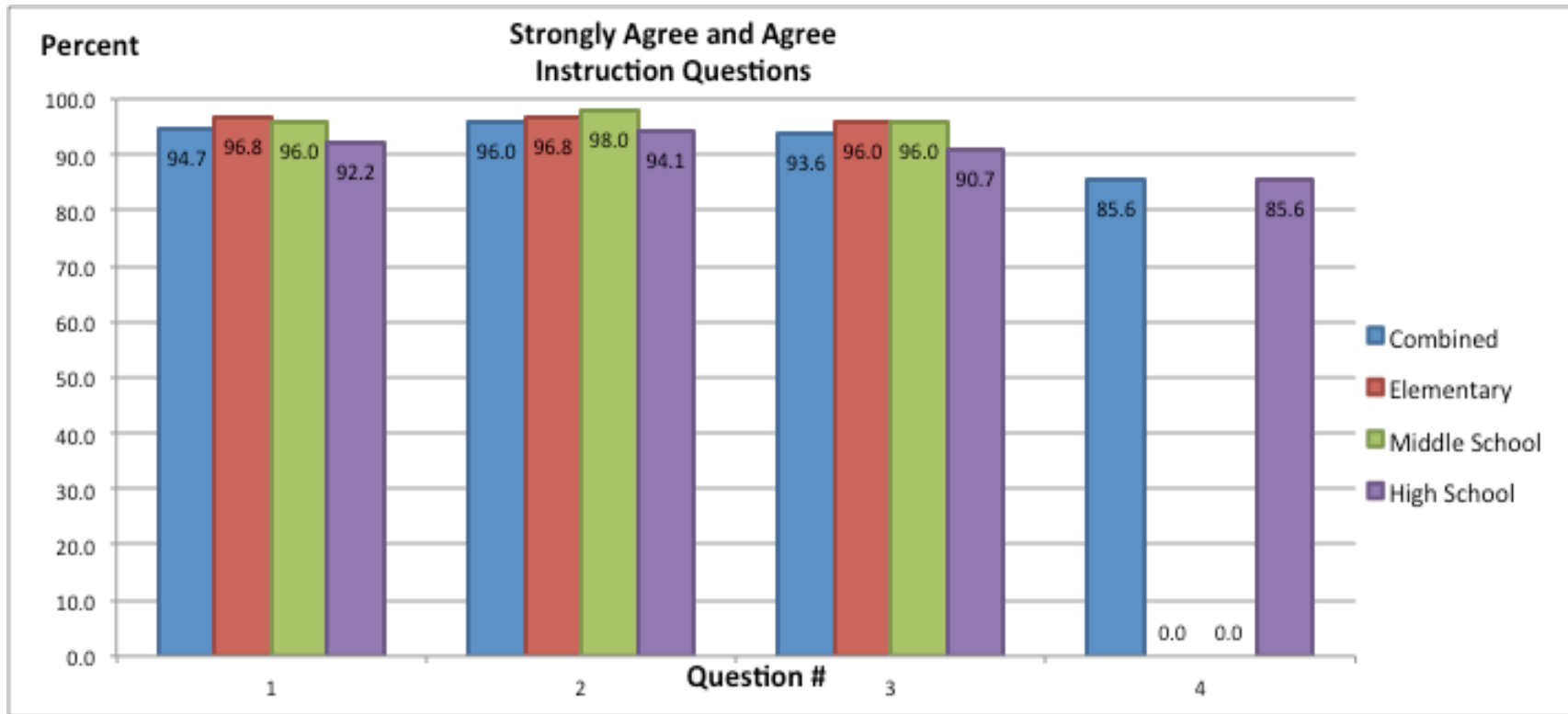

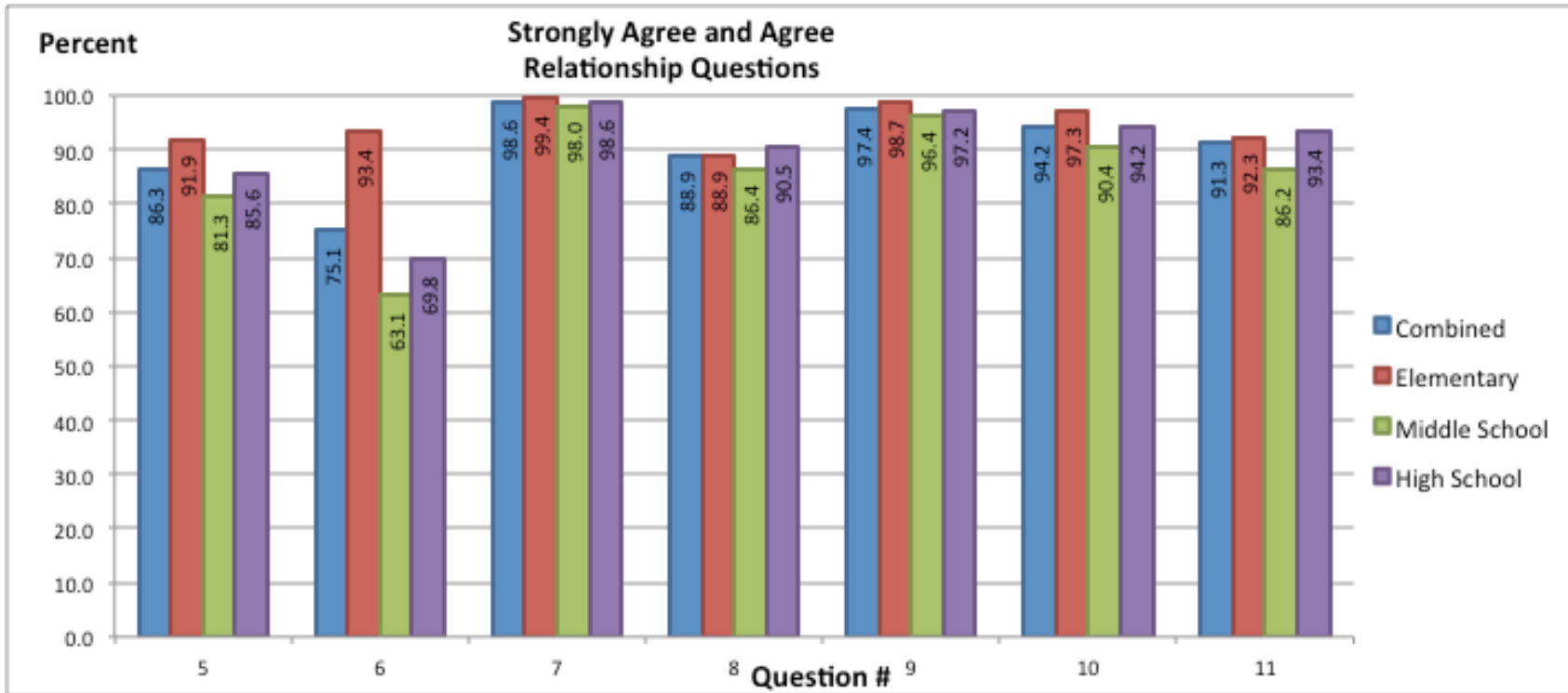

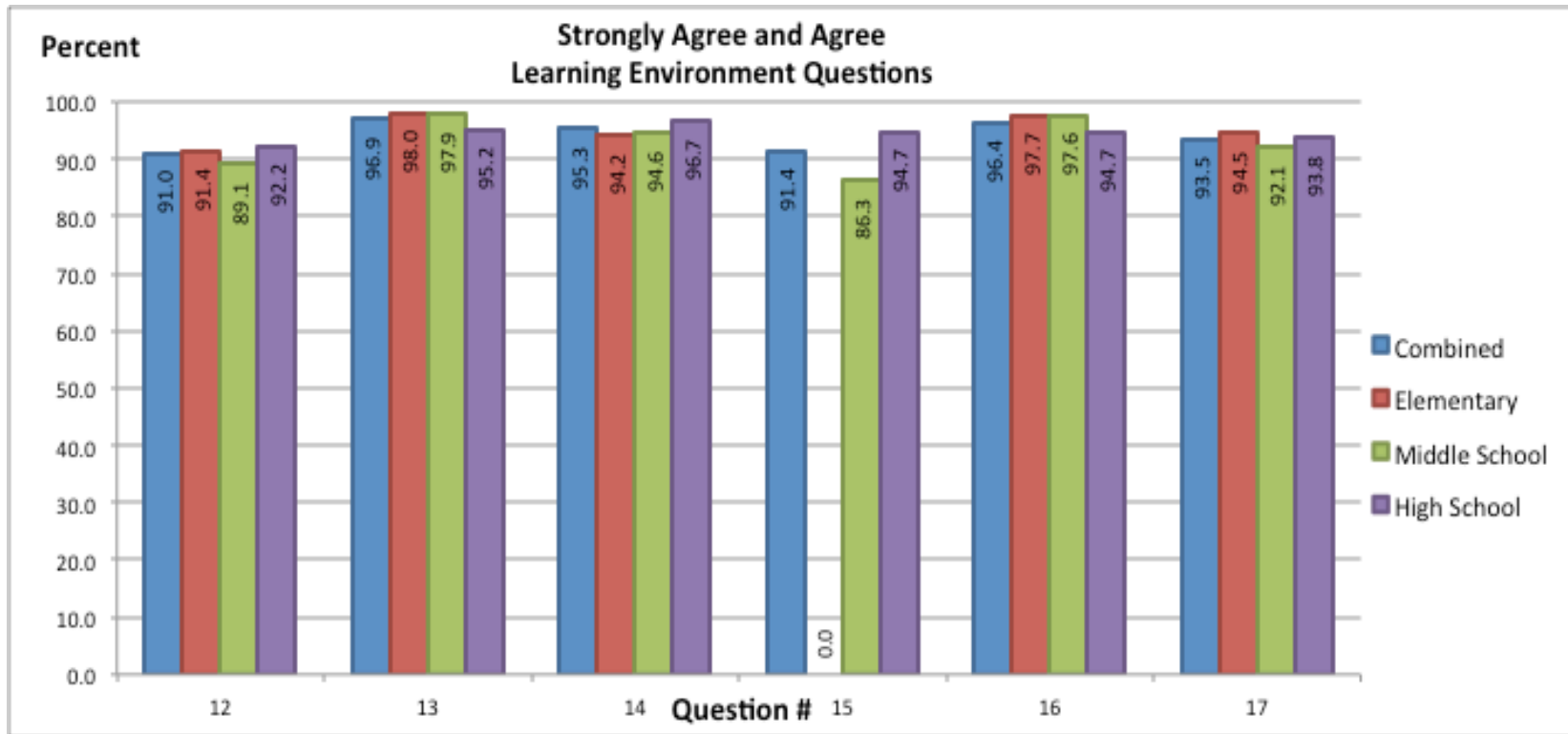

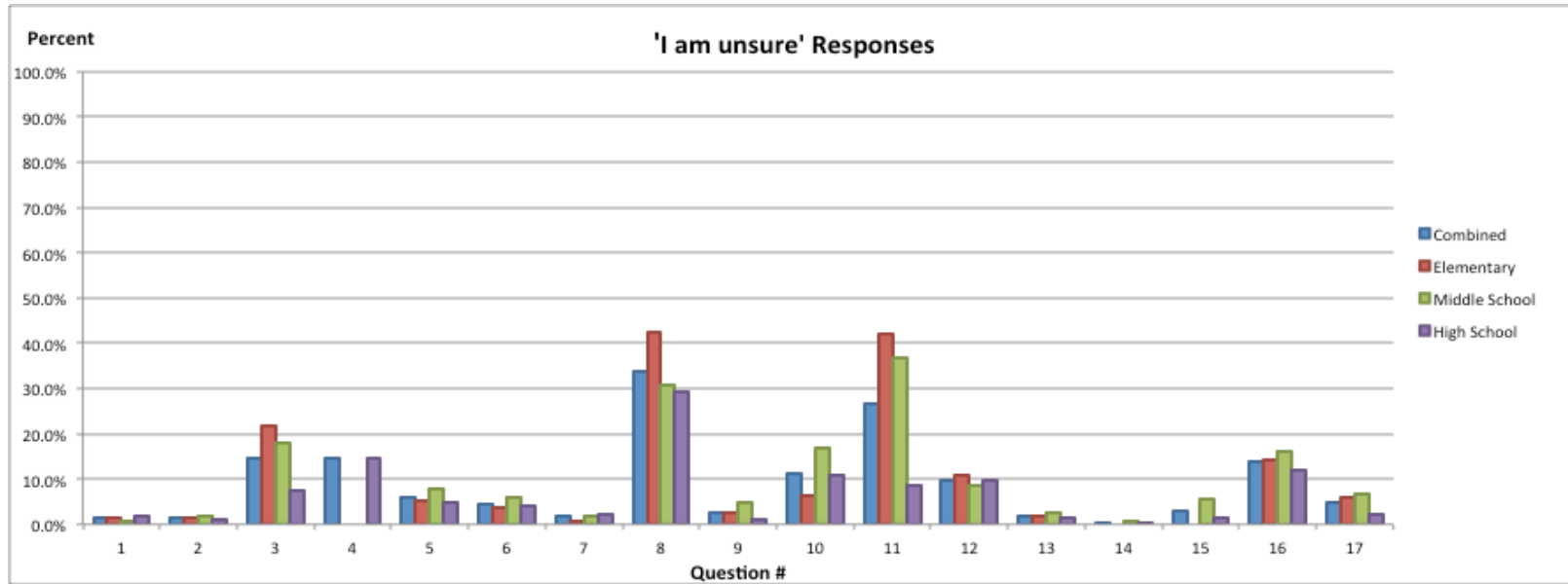
