#### 10. 5:44 Peak to Peak End-of-Year Financial Transfers and Appropriations

Motion to approve the 2019-20 end of year bank transfers, which are \$200,000 from food services to P2P operating to cover payroll and procard expenses \$400,000 from P2P operating to Colotrust reserves to earn interest on surplus cash: Thomas Willetto Seconded: Ari Axelrod

#### 11. 5:48 Q4 End-of-Year Financial Reports for 2019-20

Sam Todd reviewed the report and answered any questions. The executive summary is as follows:

"Peak to Peak (P2P) received a 4.6% increase in state per pupil (PPR) funding in 2019-20. Even though the school had to shut down in mid-March due to the COVID-19 pandemic, P2P was still able to grant pay increases and finished the year better than budgeted. Total Fund 11 revenues and transferred-in fundraising donations from Friends of Peak to Peak came in at \$17.8 million, or 99% of budget; while expenditures came in at \$17.3 million, or 97% of budget. A budget surplus of \$395K was generated for the fiscal year, leaving financial reserves in good shape at nearly \$5.6 million." Mr. Todd also reported that the request to the BVSD to distribute COVID relief funds on a perpupil basis has been denied. However, all money is being held by the district and P2P will submit invoices of all COVID-related costs.

# 12. 6:00 2020-21 Reintroduction Plan

Kelly Reeser and level principals reviewed the current plan and answered any questions. Items of note are:

- Peak to Peak continues with plans to open in Phase 2. BVSD has elected to open in Phase 1 for multiple reasons.
- In-person Kindergarten (on a part-time basis) starts next week
- Other small groups of students shall start on campus September 1<sup>st</sup>
- All health and safety processes and procedures are in line with guidelines from the district, CDE and CO Dept of Health
- School website is being updated with current information continuously
- Melissa Christensen reviewed the overall plan for engaging 1-5 students in an online environment. Each teacher will also be recording videos of how their classes will work.
