## **Message From Your Superintendent**

Dear Grand Island Families and Community:

Over the last five years, I have been continuously impressed with our incredible school system and the wonderful opportunities available for all of our students. I have also been impressed with our Board of Education and their commitment to the budget planning process. Each board member has been actively involved in the development of the budget, asking thoughtful questions and reviewing all aspects of our expenditures as well as anticipated revenues.

As a result of the extensive planning, analysis and future projections, the Grand Island Central School District is committed to providing our families and community with the necessary budget information to make an informed decision on **Tuesday May 18, 2021**.

Our proposed budget balances the needs of both the taxpayers of the Grand Island School Community and our students through the development of a fiscally responsible budget designed to provide our students with the best diversified educational program.

The 2021-22 budget total is \$67,118,207. This budget will result in a tax increase for Grand Island homeowners of 3.21%, which is within the state's tax levy cap limit. The school tax bill on a \$150,000 home, with a basic STAR assessment reduction, is estimated to increase by \$95.25. It is important to note that the tax levy calculation includes capital expenditures from our 2019 approved capital project as well as our prior approved capital projects. Furthermore, the tax levy calculation includes our bus purchases and our contribution to the Erie 1 BOCES capital improvement project which was approved in June of 2019.

This fiscal plan upholds the goals of the Board of Education and maintains our current elementary class sizes; continues the implementation of our regular instructional program; maintains current transportation services; enhances our student support programs, improves upon a safe and secure campus and provides exceptional literacy support in our elementary schools. Moreover, it maintains the current interscholastic athletic and co-curricular programs and appropriates well-planned reserves to address potential future reductions in federal and state aid, while still considering the District's fiscal future.

Voting on the school budget as well as the Board of Education candidates will take place in our high school gymnasium on Tuesday, May 18, 2021. You may also request an absentee ballot by contacting our District Clerk. All absentee ballots must be received on Tuesday, May 18 by 5 p.m. You may also wish to review our budget presentation, which can be accessed on our website at www.grandislandschools.org. Your consideration of the 2021-22 school budget is greatly appreciated.

## Proposition No. 1 (2021-2022 Budget)

Shall the following resolution be adopted?

RESOLVED, that the budget for the Grand Island Central School District (the "District") for the fiscal year commencing July 1, 2021 and ending June 30, 2022, as presented by the Board of Education in the amount of \$67,118,207, is hereby approved and adopted, and the required funds therefor are hereby appropriated and the necessary real property taxes required shall be raised by a tax on the taxable property in the District to be levied and collected as required by law.

#### **Proposition No. 2**

Shall the following resolution be adopted?

RESOLVED: (a) That the Board of Education of the Grand Island Central School District, in the County of Erie, New York (the "District"), is hereby authorized to acquire various school buses and vehicles, and to expend therefore an amount not to exceed \$710,000; (b) that a tax is hereby voted in the amount of not to exceed \$710,000 to finance such cost, such tax to be levied and collected in installments in such years and in such amounts as shall be determined by said Board of Education; (c) that the District is authorized to issue serial bonds to finance all or part of said cost, and a tax is hereby voted to pay the interest on said bonds as the same shall become due and payable; and (d) that, in lieu of bonds, the District is authorized to enter into one or more installment purchase contracts for the purchase of some or all of said buses and vehicles, for a term of not to exceed five (5) years; and a tax is hereby voted to pay each installment on any such contract.



# What are some of the items included in the 2021-2022 proposed budget?

- Maintains our current elementary class sizes
- Continues the implementation of our regular instructional program
- Enhances our administrative team to allow for a 1.0 Assistant Superintendent for Human Resources and Curriculum
- Implements the practice of a \$100,000 capital outlay project annually
- Maintains the safety and security of the campus through the School Resource Officers and security cameras
- Maintains current transportation services
- Enhances the current interscholastic athletic and co-curricular programs with the addition of modified soccer

## **Local Impact**

Our District spent \$63 million in 2019-20 to educate students. Below are estimates of the local impact.

The Grand Island School District directly employs about 500 people. The district's purchase of goods and services as well as employee personal spending is responsible for about 300 additional spillover jobs in the Western Region. The school district is responsible for a total of about 800 jobs. These jobs generate \$47.5 million in income. \$31.4 million is directly connected to Grand Island employees. Another \$16.1 million is generated by spillover spending that generates additional jobs. This income generates an estimated \$2.4 million in state income tax in total and \$1.4 million in sales tax.

#### **Tax Levy**

The tax levy is the total amount of property taxes a school district must collect to balance its budget, after accounting for all other revenue sources including state aid. The tax levy is the basis for determining the tax rate for each of the cities, towns or villages that make up a school district.

#### **Tax Rate**

Tax rate is determined by your property's assessed value divided by 1,000, and multiplied by the tax rate. This rate is established using the Town of Grand Island Assessed Value.

\*The 2021-2022 proposed tax rate is based on estimated assessment. Final assessment values for calculation of the 2021-2022 tax rate are not available at this time.

#### What happens if the proposed budget is not approved?

If a proposed budget is defeated by voters, a school district - as in the past - has two options: to put the same or a revised budget up for a revote, or to adopt a contingent budget. If a proposed budget is defeated twice by voters, a district must adopt a contingent budget.

#### Does the law make any changes to the requirements for a contingent budget?

Certain existing contingent budget requirements remain in effect which prohibit spending in specific areas including community use of buildings, elimination of all proposed increases in staff, prohibit purchasing of new equipment (i.e. buses) and prevent any member of a bargaining unit which does not have a contract beyond June 30, 2021 from having an increase in salary in 2021-2022.

However, under the new law, a district that adopts a contingent budget may not increase its current tax levy by any amount which would impose, in effect, a zero percent cap. Districts will not be allowed to increase the tax levy to the extent needed to fund expenditures excluded from the tax cap (no growth factor, nor capital, court order/judgements, or pension expenditures.).

### **Our Successes**

#### Sidway Elementary School -

Our focus is on early literacy and the conceptual development of early math skills. Literacy is taught through a workshop model, where differentiation is at its best. Sidway opened a new community playground this spring, thanks to the support of faculty, staff, students and the community. There are 4 literacy specialists at Sidway, trained in Reading Recovery, delivering the most effective reading support for students.

#### **Huth Road Elementary School -**

The Huth Road faculty work hard to adapt to the many changes they have faced in the last year. Our dedicated professionals are determined to find ways to bring academic success to all students. Building strong relationships has always been the keystone to a strong academic program. Our faculty continues to find ways to strengthen their relationships with students in whatever instructional model we are using.

#### Kaegebein Elementary School -

Our teachers and students continue to move through this school year with fluidity while adapting to the changes brought about by the pandemic. We were thrilled to welcome our elementary students back for in-person instruction five days a week! We are delighted to be able to provide our 100% Virtual Vikings with the resources and support necessary to promote the continuum of successful learning.

#### Veronica E. Connor Middle School -

The Middle School continues to move forward in light of an ever-changing academic environment. Our teachers continue to search for ways to provide engaging instruction that meets the needs of students in-person and at home. Many of our clubs and activities have continued within a virtual platform. We are looking forward to increasing in-person activities within the appropriate safety protocols.

#### **Grand Island High School** -

The High School would like to thank our parents and community members for all of their support as we have navigated through the pandemic. We are proud to have resumed many of our after-school clubs, activities and competitive sports. We continue to seek ways to return as many students as possible to in-person learning, as well as provide a diverse program and rigorous curriculum to prepare students for college and careers.
