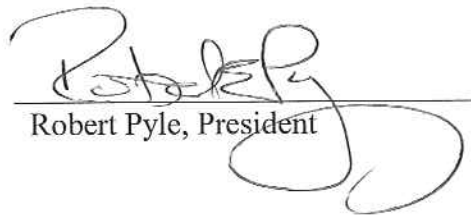
**ADJOURNMENT**
