

  what you used at enrollment (for example, Michael vs. Mike for first name).


#### You can also take advantage of these features 24/7:

- All functionality available in both English and Spanish.




### Simple, intuitive navigation



1. Access via aflac.com/login.




- 2. Members can easily access everything needed to manage their Aflac Group Dental and Vision coverage:

  - Prior authorization decisions.




- 3. Personalized provider search makes it easy for members to find convenient care with enhanced features:

#### Easily filter based on:


- Geolocation.

  - Download your explanation of benefits.
