LD. TAG GUIDELINES

- 1. I.D. Tags must be worn by all adults from the first bell of the school day through the final bell of the school day.
- 2. Employees of any Before or After School Program in the schools are expected to wear their tags.
- 3. If an employee forgets or loses his/her tag, he/slie must obtain a generic staff pass from the main office until a new permanent replacement tag is created.
- 4. In the interest of providing a safe environment for students and staff, it is the expectation of the school district that employees who observe any adult in the school who is not wearing a proper LD. tag will politely ask the adult to obtain a tag from the main office. Also expected is that a prompt follow-up call to the office is made by the employee to ensure compliance.
- 5. All new employees are expected to contact your building administrator to arrange for their photo LD, Tag.
