



**FY 25 LICENSE AGREEMENT
FOR
BAILEY FIELD ADVERTISEMENT**

This License Agreement dated _____ between The York Foundation for Public Education, Inc., a Virginia corporation (“Licensor”) and _____ (“Licensee”) establishes the terms for displaying the Licensee’s advertisement at Bailey Field on Cook Road in York County, Virginia.

TERM AND FEE: This license will operate for an annual period, beginning August 1 of the fiscal year and expiring the following July 31. However, the Licensor may direct, in writing, the Licensee to remove the advertisement at an earlier date. In this event, or in the event Licensee requests early removal, the Licensee shall not be entitled to any remuneration for early removal. The fee for this license is **\$300**, payable upon execution of this License Agreement.

SIZE OF ADVERTISEMENT: Unless otherwise specified herein, the Licensee agrees to utilize the designated sign company to purchase a vinyl wrap at Licensees own cost. Such vinyl wrap shall be affixed to a 4x8 PVC board provided by Licensor. Once erected at Bailey Field, the advertisement is the personal property of the Licensor.

LOCATION OF ADVERTISEMENT: The Licensee’s advertisement will be mounted and displayed with the advertising on the interior security fence surrounding the track and playing field of Bailey Field.

PREPARATION OF ADVERTISEMENT: The sign shall be manufactured and maintained at Licensee’s sole cost to the standards promulgated by the Superintendent of the York County School Division. The designated sign company will perform mounting of the sign on the Bailey Field fence.

MAINTENANCE OF ADVERTISEMENT: Licensee will perform routine cleaning and necessary maintenance to repair normal wear and tear of the advertisement at no cost to Licensor and shall make arrangements with Licensor to access Bailey Field during Licensor’s normal business hours. Licensee shall bear all risk of damage to, or theft of, the sign, Licensee agrees specifically that neither the Licensor nor the York County School Division, shall be liable to Licensee for loss of or damage to the sign occasioned or alleged to be occasioned to any degree, by a failure to secure the confines of Bailey Field or to lock the gate to the surrounding fence. If the advertisement is stolen, faded or is destroyed or damaged by vandals or acts of God, the Licensee shall bear all costs of repair or replacement and will have the option of having a replacement advertisement, prepared at Licensee’s cost, placed on the fence for the remainder of the duration of this Agreement. The replacement advertisement will be posted in the same location as the original advertisement. The term of this License Agreement will be unaffected by posting of a replacement advertisement. Upon expiration of this Agreement, and failure to renew, Licensee’s advertisement will be removed by Licensor. Licensor shall not be responsible for any loss or damage to the advertisement that may occur during removal. Licensee hereby releases Licensor, its officials, officers, agents and employees from all liability arising out of Licensor’s removal of Licensee’s advertisement at any time during the term of this Agreement.

SCOPE OF LICENSE: The Licensee acknowledges and agrees that this License Agreement is for the display of an advertisement at Bailey Field only. Expressly, display of an advertisement at Bailey Field constitutes no endorsement of a product by the Licensor or by the York County School Division or implies any other relationship between the Licensor or the York County School Division and the Licensee.

CONTENTS: Advertisements will comply with the York county School Division’s policy on advertisements at Bailey Field. The Licensor designates the Division Superintendent to resolve any issue arising from a proposed advertisement and its compliance with School Board policy KJ.
