#### **Addendum Information**

Clarifications and responses to proposer's questions:

- 1. The Dental Assistant Program should be included in the proposal.
- 2. Has the roof at WECES been recently replaced?

The roof has not been replaced. The roof warranty expires in 2026.

- 3. The RFP indicates an award date of April 1, 2024. Is there a revised date that you can provide, so that we can update our preliminary schedule accordingly?
  - RCPS anticipates selecting a firm in November or December and executing an agreement in January.
- 4. Does RCPS know what equipment they would like to re-use or would like replaced at each of the schools?
  - It is not our desire to re-use any of the existing FF&E. However, what you include in your proposal is up to you and will likely be based on the budget available.
- 5. Can RCPS provide direction as to what CTE equipment is to be replace and reused? It is up to the proposer to determine what equipment should be brought over and what should be replaced. As with the FF&E, this is likely to be based on the available budget and condition of existing equipment.

- 7. Is a letter from our bonding company being requested to ensure we have the available bonding capacity to perform the work?

- c. Third Party Construction Management Fees or Clerk of the Works Cost TBD
- d. Commissioning Fees Cost TBD
- e. Special Inspections/Construction Materials Testing/Hazardous Material Testing and Monitoring Cost TBD
- f. The cost for any building permit fees, plan review fees, and site improvement/erosion bonds (anticipated to be paid directly by the Owner or waived by the County of Roanoke) For the purposes of this proposal, please consider these fees as part of your contract.

- I. Moving, Storage, and Relocation of Existing Furniture and Teacher Materials (Glen Cove and Cundiff Elementary Schools) - Teachers will be responsible for moving teacher materials. Any moving, storage and relocation of existing furniture that is required for construction phasing will be performed by the Design-Builder. - For the purposes of this proposal, please consider these fees as part of your contract.
- m. Relocation and storage of existing CTE Equipment to be re-used The intent is for all equipment to remain in use until the CTE Center can be occupied. At this time, it is expected that the Design-Builder will relocate/reinstall any reused equipment. For the purposes of this proposal, please consider these fees as part of your contract.
- n. Bringing utility services (water, sanitary sewer, primary power, natural gas, fiber, cable, telephone) to a point of connection at the property line or designated point of demarcation if needed Cost TBD
