

# Sanger Independent School District iPad Agreement 2024-2025

I acknowledge that my student and I have received the following documents and an assigned iPad. As a parent/guardian, I will ensure that my student and I read the documents before using his/her assigned iPad for the first time.

- Sanger Independent School District iPad Program Handbook (posted on the district websites)
- Sanger Independent School District iPad Agreement and Internet Safety Agreement
- Sanger Independent School District Responsible Use Agreement in the Student Code of Conduct and Student Handbook

## ***Student Agreement***

As a learner, I agree that I will:

- use my assigned iPad for my educational purposes only;
- follow the procedures and policies outlined in the iPad Program Handbook, Student Handbook, Code of Conduct, and the Internet Safety Agreement both at school and home;
- protect my assigned iPad by carrying it securely and safely;
- charge my assigned iPad's battery to total capacity each night;
- report all damages to or issues with my assigned iPad to the proper school personnel as soon as they occur;
- never alter or attempt to change the management setting on my iPad;
- never leave my assigned iPad unattended in an unsecured or unsupervised location;
- and never share my assigned iPad or charger with other students, family members, or others.

I understand that any violation of this agreement may result in suspending or losing my iPad and school network privileges. Additionally, I may face disciplinary action for such violations.

## ***Parent Agreement***

I understand that my family's responsibilities include:

- ensuring my child meets the expectations outlined in the iPad Program Handbook, Student Handbook, Code of Conduct, and the Internet Safety Agreement;
- protecting my student's assigned iPad, case, and charger, within reason, against damage, loss, or theft while it is at home or outside of school, and ensuring my child reports damage to school personnel.
- ensuring my students use the iPad and charger only for educational purposes.

In consideration of the privileges and opportunities afforded by the use of SISD technology resources, I hereby release SISD and its employees from any and all claims of any nature arising from my child's use or inability to use these resources, including but not limited to claims that may arise from unauthorized use of an iPad.

I also understand that Sanger ISD can't restrict access to all controversial materials. I will not hold the District responsible for materials accessed with a Sanger ISD iPad.

I accept full responsibility for my student's use of his/her assigned iPad while not in a school setting and understand that my student's iPad use is subject to the same rules and requirements when used off-campus. I understand that my student's iPad privileges may be suspended or revoked for violation of this agreement.

I understand that per State Education Code 31.104(d), the district or school may withhold the student's records if the district technological equipment is not returned in an acceptable condition or paid for when a student withdraws from the district or at the end of the school year. Records withheld include transcripts to other schools and universities.

I understand that should damage occur to the iPad assigned to my child, I will be solely responsible for reimbursing the school for repair or replacement costs.

I understand that SISD has made insurance available for the iPad assigned to my child. If I choose not to purchase the insurance, I am responsible for the full costs listed below.

**Damage Cost Examples - other components charged at different rates**

<b>Component</b>	<b>Repair/Replacement Cost</b>
Screen Replacement	Glass only - \$50- 1 <sup>st</sup> , \$100-2 <sup>nd</sup> , Full cost for all subsequent incidents LCD only - \$100- 1 <sup>st</sup> , \$150-2 <sup>nd</sup> , Full cost for all subsequent incidents Shattered/Destroyed - \$125- 1 <sup>st</sup> , \$175-2 <sup>nd</sup> , Full cost for all subsequent incidents
Keyboard/Case Replacement	\$110 for Combo 4 for iPad 10th generation \$90.00 for Combo 3 for iPad 7/8/9th generation (or replacement cost from Apple)
Charging Cord	\$19 (or replacement cost from Apple)
Power Adapter	\$19 (or replacement cost from Apple)
iPad Replacement	\$410 (or replacement cost from Apple)
