I acknowledge that my student and I have received the following documents and an assigned MacBook Air. As a parent/guardian, I will ensure that my student and I read the documents before my student uses his/her assigned MacBook Air for the first time.

- Sanger Independent School District MacBook Program Handbook (posted on the district websites)
- Sanger Independent School District MacBook Agreement and Internet Safety Agreement
- Sanger Independent School District Responsible Use Agreement in the Student Code of Conduct and Student Handbook

Student Agreement

As a learner, I agree that I will:

- use my assigned MacBook Air for educational purposes only;
- follow the procedures and policies outlined in the MacBook Air Program Handbook, Student Handbook, Code of Conduct, and the Internet Safety Agreement both at school and home;
- protect my assigned MacBook Air by carrying it securely and safely;
- leave the MacBook Air in the district provided clamshell case;
- charge my assigned MacBook Air's battery to full capacity each night;
- report all damages to or issues with my assigned MacBook Air to the proper school personnel as soon as they occur;
- never alter or attempt to change the management setting on my MacBook Air;
- never leave my assigned MacBook Air unattended in an unsecured or unsupervised location;
- and never share my assigned MacBook Air or charger with other students, family members, or other individuals.

I understand that any violation of this agreement may result in suspending or losing my MacBook Air and school network privileges. Additionally, I may face disciplinary action for such violations.

Parent Agreement

I understand that my family's responsibilities include:

- ensuring my child meets the expectations outlined in the MacBook Air Program Handbook, Student Handbook, Code of Conduct, and the Internet Safety Agreement;
- protecting my student's assigned MacBook Air, within reason, against damage, loss, or theft while it is at home or outside of school, and ensuring my child reports damage to school personnel.
- ensuring the MacBook Air and charger is used for educational purposes for my student only.

In consideration of the privileges and opportunities afforded by the use of SISD technology resources, I hereby release SISD and its employees from any and all claims of any nature arising from my child's use or inability to use these resources, including but not limited to claims that may arise from unauthorized use of a MacBook Air.

I also understand that Sanger ISD can't restrict access to all controversial materials. I will not hold the District responsible for materials accessed with a Sanger ISD MacBook Air.

I accept full responsibility for my student's use of his/her assigned MacBook Air, clamshell case, and charger while not in a school setting and understand that my student's MacBook Air use is subject to the same rules and requirements when used off-campus. I understand that my student's MacBook Air privileges may be suspended or revoked for violation of this agreement.

I understand that per State Education Code 31.104(d), the district or school may withhold the student's records if the district technological equipment is not returned in an acceptable condition or paid for when a student withdraws from the district or at the end of the school year. This includes transcripts to colleges and universities.

I understand that should damage occur to the MacBook Air assigned to my child, I will be solely responsible for reimbursing the school for repair or replacement costs.

Sanger ISD has made insurance available for the MacBook Air assigned to my child. If I choose not to purchase the insurance, I am responsible for the full costs listed below.

Damage Cost Examples - other components charged at different rates

Component	Repair/Replacement Cost
Screen Replacement	\$200 1 st , \$300-2 nd , Full cost for all subsequent incidents
Keyboard/Topcase Replacement	\$150 1st, full cost for all subsequent incidents (or replacement cost from Apple)
Trackpad	\$100 1st, full cost for all subsequent incidents (or replacement cost from Apple)
USB-C Power Cord	\$29 (or replacement cost from Apple)
USB-C Power Brick	\$39 (or replacement cost from Apple)
Extender Cord	\$19 (or replacement cost from Apple)
Carrying Case or Clamshell Case	\$35 or actual replacement cost
MacBook Air Replacement	\$699 (or replacement cost from Apple)
