- A. 211 Criminal or Civil Action Against School District, School Board Member, Employee or Student: Mr. Berzinski presented this policy with minor language, and statute and legal reference updates. Mr. Hanratty and Ms. Smith recommended that the policy be added to the July 18, 2024 School Board agenda for first reading by the School Board.
- **B. 409 Employee Publications, Instructional Materials, Inventions and Creations:** Mr. Berzinski presented this policy with no proposed changes. Mr. Hanratty and Ms. Smith recommended that the policy be added to the July **18**, 2024 School Board agenda for review by the School Board.
