SUBJECT: District Wellness Committee -- Annual Report

Board of Education policy/procedure #5602 was updated in November 2014, June 2017, and June, 2023. The policy requires that a committee meet throughout the school year and report to the superintendent annually. Please consider this the annual report for 2023-24. The policy also requires an annual public hearing for community/public input. This hearing will be placed on the Board of Education meeting agenda.

Invited membership representation on the committee included: School Food Service Personnel, Classroom Teaching Personnel, Parents, Administration, Board of Education and Community Representation.

All meetings of the District Wellness Committee were held at the Central Office.

Actions/Discussions during the 2023-24 school year included:

1. Review of the district's food service program.
2. Preparation for the formal USDA review of the district's food program, including policy assessment and evidence collection.
3. Review of Policy 5602 for recommended changes.
4. Wellness goals and programming in the district.

Meeting dates for 2024-25 are pending. All meetings shall be held at the Central Office at 3:30-4:00 P.M.

Initial goals/ideals for 2024-25 include:

- Continue to review district wellness initiatives--including mental health--and determine if other wellness activities for students need to be implemented in the District.
- Review and monitoring of goals outlined in Policy 5602.
