All payments will be made on December 19. Taxes and PERSI will be submitted on December 19 and all other deductions will be processed and submitted to the appropriate vendors/agencies on December 19. The Payroll Office will not be able to help resolve issues until January 6, 2025.

3: January 3, 2025 payroll:

Payroll will be processed on January 2. All payroll items for 12-month employees must be received by 10:00 a.m. on January 2 in order to be processed. All other locations must submit payroll items / data by December 19, 2024.

4: June 18, 2025 payroll:

The payroll will be processed on June 18, 2025 to accommodate the Juneteenth federal/banking holiday on June 19, 2025.
