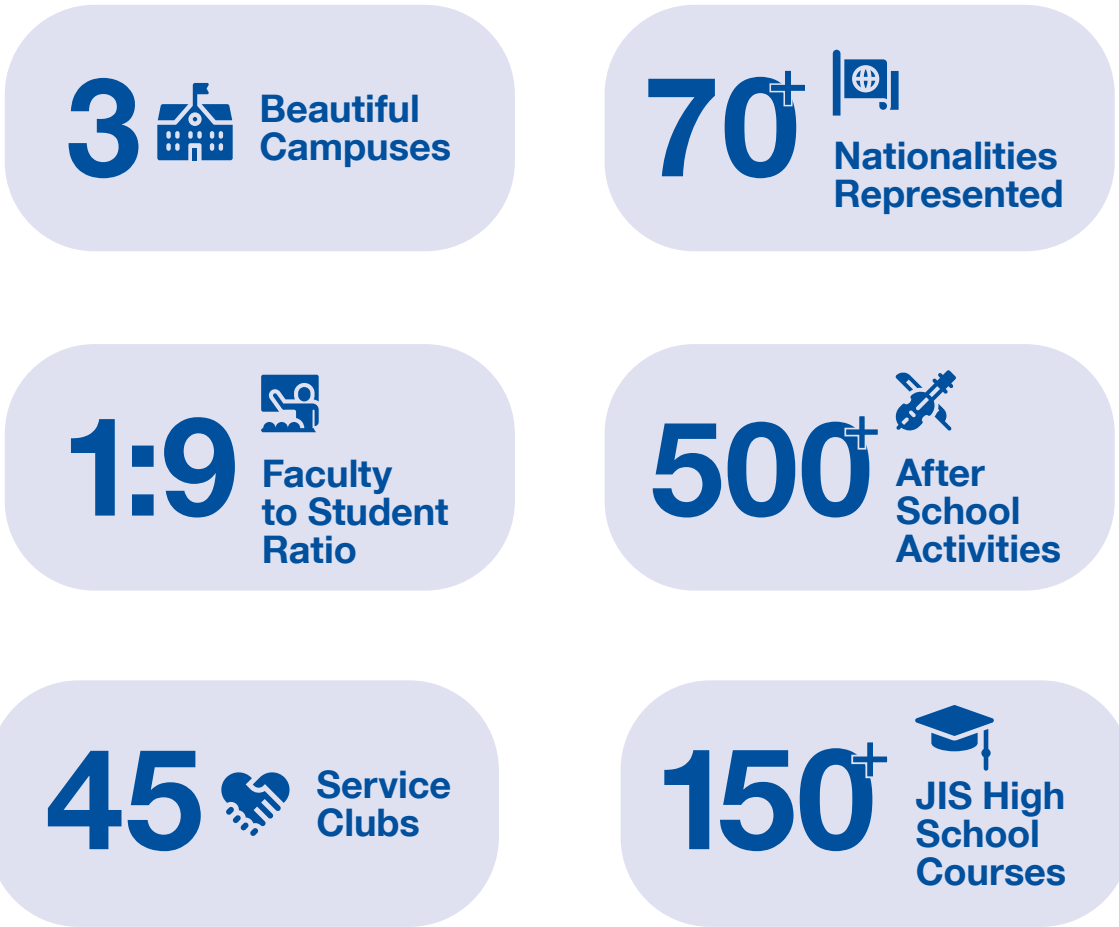

Jakarta Intercultural School (JIS) operates as a not-for-profit foundation, fully committed to realizing its vision and mission of delivering the best education in Indonesia.

All revenue is reinvested into the school to ensure students receive an exceptional learning experience. This means that 100% of our tuition and fees go directly into the school to build world-class facilities, hire experienced educators from around the world, support student learning with resources and programming, and ensure that our campuses are well-maintained and secure.

### JIS in Numbers



Fees are reviewed annually and are subject to change. All fees are quoted and are payable in Rupiah and include 0% VAT where applicable. VAT is subject to change.

#### Application Fee

A non-transferable and non-refundable fee of **IDR 5,300,000 per student** is immediately due upon submission of a student’s application to JIS.

#### School Fees

##### Enrollment Guarantee Fee

A mandatory annual, non-transferable and non-refundable fee. The annual Enrollment Guarantee Fee is a portion of the school fee paid in advance to confirm acceptance of an offered place; or, for continuing students, to reserve a place for the next academic year, until school fees are due.

##### Lane 3 High School Surcharge Fee

A mandatory one-time, non-transferable and non-refundable fee for all Lane 3 Grade 10 and Grade 11 applicants. These applicants are students transferring from a local or international school in the Greater Jakarta area (Jabodetabek).

##### Technology Fee

A mandatory one-time, non-transferable and non-refundable technology fee for new students.

##### Tuition Fee

A mandatory annual fee representing the cost of delivering instruction to enrolled students.

##### Capital Fee

A mandatory annual non-transferable, non-refundable fee that directly supports the development of the school’s infrastructure facilities and fixed assets.

Supplementary Fees

Supplementary Fees will be charged for elective or discretionary student activities including experiential learning LEAD Week activities, international sporting and cultural trips, trips associated with individual courses, IB and AP exam fees, graduation, musical instrument hire and other activities. Invoices will be sent separately to parents.

English as Additional Language (EAL) Fees

A one-time fee of **IDR 71,318,000** will be charged to students requiring EAL support based on the assessment performed by the School. If JIS determines a student requires English as an Additional Language at any point while enrolled at JIS, the student must join the EAL program in order to remain enrolled.

The above transportation fees are based on normal capacity and school days. The fees will be adjusted if the government regulations or circumstances require otherwise.

Billing Arrangements and Responsibilities

**Direct Company Billing** - Students whose school fees will be billed to and paid for by a sponsoring organization, whether by a company, Embassy or any other organization, must submit a letter of sponsorship which is signed by the Authorized Financial Officer of the organization and stamped with the organization's seal. School fee invoices shall be sent to the parent and the person or party identified on the sponsorship letter.

**Self-Pay Billing** - Students whose school fees are billed only to the parents and are paid directly to the school from the parent's personal account.

The parents/legal guardians of an enrolled JIS student are responsible for ensuring that their financial obligations to JIS are met in full and on time, regardless of whether they have made Self-Pay or Direct Company Billing arrangements. Any changes in billing arrangements must be sent in writing to **JIS Admissions (admissions@jisedu.or.id)**.

Terms of Business

Payment

Full payment of school fees is the only way to guarantee enrollment at JIS. Below are the due dates of SY 2025-26 school fees:

Annual	June 15, 2025
Semester (for Self-Pay Billing only)	Semester 1: June 15, 2025 Semester 2: November 15, 2025

For students admitted after June 1, 2025, payment is due in 14 (fourteen) days or before the school term starts, whichever is earlier. For students admitted after the school year has started, full payment is due immediately.

A student may only start attending classes after full payment of fees is received.

Pro-Ratio

**For Self-Pay Billing**, once a student enrolls at JIS, regardless of the actual number of days of attendance, the Tuition, Enrollment Guarantee, and Annual Capital Fees are payable in full for the whole school year or semester. The Annual Enrollment Guarantee Fee and Annual Capital Fee are not prorated, not transferable, and are not refundable.

**For Direct Company Billing**, once a student enrolls at JIS, regardless of the actual number of days of attendance, the Tuition, Enrollment Guarantee, and Annual Capital Fees are payable in full for the whole school year. If a student enrolls in the second semester, the Tuition, Enrollment Guarantee, and Annual Capital Fees are payable in full for the whole semester. The Annual Enrollment Guarantee Fee and Annual Capital Fee are not prorated, not transferable, and are not refundable.

Financial Assistance

The School has limited funds to provide partial financial assistance and scheduled payments for Self-Pay Billing parents who are facing temporary financial hardship. Applications must be made by completing forms by the deadline of April 4, 2025.

Financial assistance is not available for new students.

Bank Charges

All costs incurred in making bank transfers for the payment of fees are for the account of the transmitter and not the School.

Terms of Business

Refunds

Refunds for a semester school fees will be granted according to the following guidelines:

- Attendance of any day in a semester constitutes full attendance for the semester and no refunds for that semester will be given.
- Refunds will only be given to students who submit a Withdrawal Notice and Refund Form.
- No refund will be given to students who submit a Withdrawal Notice after the following dates:

Semester 1	Semester 2
July 15, 2025	December 1, 2025

Refunds that remain unclaimed four years from the date of entitlement will be transferred to the JIS Operating Fund.

In the event that a student is **temporarily withdrawn** for a semester, parents can opt to:

1. Pay the Annual Capital Fee and Tuition Fees for the semester of non-attendance to maintain placement, or
2. Withdraw and request that the student is placed on the wait pool for readmission at the start of the following semester.

Force Majeure

In the event of any inability or delay in the School’s ability to deliver or perform any or all of its obligation under this Agreement resulting from force majeure (including inability to provide the educational services online or remotely) as causes beyond the School’s reasonable control and occurring without its fault or negligence, including (without limitations): acts of nature, fire, flood, an outbreak of diseases, epidemic, pandemic, concerns with local or national safety and security, actions of government or government restrictions, riots, sabotage, changes in legislation directly related to the implementation of the School’s services, wars, and insurrections, provided that, the School has acted in good faith to minimize the effect of the force majeure, you hereby acknowledge that your obligations under this Agreement shall continue and remain valid, and the School will have no liability in respect of any such inability or delay in its provision of services under this Agreement. The School shall notify the occurrence of the force majeure event within a period of no later than 14 (fourteen) days from the date of the occurrence of force majeure to the parents/ respective guardians.

Subject to the clause above, if the school has to close for reasons of force majeure, the Head of School will withhold all tuition refunds until the settlement of outstanding liabilities has been completed. Money left after these settlements would be divided proportionally among parents, companies and organizations to be credited to their school’s account(s). No cash refund should be expected. Accounts credits would be maintained for 4 (four) years after the School closure at which time they will be reverted to the School’s general fund.

Penalties for Late Payment

Withdrawal of Enrollment

If school fees remain outstanding 14 (fourteen) days after the due date, the school reserves the right to withdraw the student’s enrollment.

Interest

Interest will be charged at a rate of 2% per month on any outstanding balance of Tuition and other fees. This charge will also apply to Direct Company Billing Students who do not pay the Tuition Fee for the second semester but decide to reenroll and continue from the First Semester to the Second Semester.

Suspension

Continuing students will be subject to suspension for non-payment of fees, unless approved by the Chief Financial Officer. Report cards and transcripts will be withheld until all outstanding fees, including interest, have been paid in full.

Legal Action

In the event that a family withdraws without settling their accounts with the school, the School reserves the right to hold the student’s record and diploma and seek legal recourse to recover all amounts due through the Indonesian Courts or international debt collection agencies.
