MINUTES THE ASHEVILLE CITY BOARD OF EDUCATION WORK SESSION OCTOBER 26, 2015, SPECIAL MEETING AND REGULAR MEETING NOVEMBER 2, 2015

The Asheville City Board of Education ("Board") held a work session at 4:00 p.m., on Monday, October 26, 2015, in Training Room 203 of the Asheville City Schools Administrative Offices, 85 Mountain Street, Asheville, North Carolina.

CALL TO ORDER

Vice-Chair Matt Buys called the work session to order at 4:03 p.m.

WORK SESSION

The Board received School Improvement Plan updates from five of the district's nine schools that are listed below. The principals' presentations were condensed to a two-page template report, where they stated the mission of their schools and the district's vision. A summarized strategic map on how to incorporate equity for all students with the Strategic

Plan three focus areas: Early Childhood, Academic Achievement and Whole Child, with their goals and desired outcomes were shared.

A review of their action steps that aligns with the district's 2015-2020 Strategic Plan was also presented. The 25-minute presentations allowed for questions and answers with the Board. The Board will review the schools' SIP detail reports, which will be on the December 7, 2015 regular Board meeting agenda for their consideration and approval.

Before her presentation of the 2015-2016 Budget, Donna Watson thanked Budget Analyst, Sarah Banks for her assistance in the preparation of the presentation. Each board member had the opportunity to review the PowerPoint presentation prior to the meeting, and it included an overview the Schools Capital Commission Fund and Cash Flow Projections for Asheville City School. In addition, a Five-Year Facilities Repair and Renovation Plan that were developed from a Comprehensive Facilities Study that was conducted by an architectural firm in January of 2014, which has since been modified to include renovation needs at the high school, and the planned restructure process. Additional conversation around the restructure will be an agenda item at the January 14, 2016 Board Mid-Year Retreat. The power point presentation of the total budget of \$90,258,065 was presented and reviewed with the Board. The Fiscal Year 2016 Budget Resolution will be presented to the Board the November 2, 2015 regular board meeting for their consideration and approval.
