The decision before the Board of Education was presented by Attorney Campbell. There are two options to consider: Closing a school and moving students to another school to save money. All of the students who would like to remain in Montessori through third grade have been assigned to the Montessori School located at Hall Fletcher Elementary. This option is a location/facility change for students with a principal and Montessori staff. The legal option advised was to physically move the students to another location since the recommendation was made to follow the school closure statute. Mrs. Dockery has presented the APS Work Study that was completed and posted on the ACS website. Option one: The Board of Education will consider the study and decide to adopt it as the official study of the school system. Option Two: Vote to close the Asheville Primary School location and reestablish the school at the Hall Fletcher School location. The vote is to ONLY close the geographic location, not the Montessori Pre-K and K-3rd grades.

- HomeTrust Bank Principal of the Year and Teacher of the Year Presentation: Dr. Dechant, Director of Recruitment and Induction, and Susan Puryear, Director of Professional Banking & Investment Services presented to Asheville High School Principal Derek Edwards and Ira B. Jones Teacher Susanna Cerrato a check and congratulations. Dr. Dechant also mentioned that Ms. Cerrato was the Western Region Teacher of the Year and a finalist for the North Carolina 2021 Teacher of the Year.
- Budget Amendments, Budget Updates and the Local Budget FY22: Georgia Harvey, Executive
  Director of Finance shared budget amendment 521 which is an addition of \$700.00 from the state
  for substitute pay. An allotment for summer reading camps \$87,465. Transfer of funds from CTE
  for months of employment to instruction funds \$44,235. Transfer from state textbooks 130 to 131
  which will give more flexibility to spend funds for state instructional textbooks.
- <u>Contract/MOU's</u>: Dr. Cassida, Assistant Superintendent of Auxiliary Services presented the following contract for approval.
  - APD Off Duty Management (ODM) the Board of Education would like to remove from the contract, "Then a second term will be from August 1st, 2021 to February 2, 2022." At this time it will be approved for the 1st term of the MOU from February 2, 2021 and

terminating on July 31st. Dr. Cassida will check with the sheriff's department to inquire about their hourly pay for off duty officers and report back at the next meeting.
