## INFORMATION AGENDA

- Approval to explore selling the Asheville Primary campus: Dr. Freeman shared that there is space within the district at Vance, MNSA, and Hall Fletcher for all of the students in the Montessori Program and the Preschool. There is no need to keep the APS building. Things to think about are the cost for the insurance and liability on the building. Renovations can run 9 million and would take 18 to 24 months. To build a new building it would cost around 24 million.
- Housing Internet Contract: The contract has been revised to include Buncombe County Schools.
  This is a four-year commitment. CARES money is going in to help pay for some of the monthly
  expenses. Asheville City Schools Foundation will be paying monthly on behalf of Asheville City
  Schools.

• EOC and CTE Testing Update: Ian Nelson, Director of Testing; Laura Parks, Director of Secondary Education, shared the make-up exams schedule. Makeup exams can be made up at the end of January 2021 and at the end of the spring and summer semesters. There will be assistance for testing prep for students who make-up exams at the end of the spring and summer. A 59% grade will be a placeholder until the student makes up the test then that will be replaced with the new grade if it is higher. A 59% would not cause anyone to fail a course. The Board of Education and Dr. Freeman requested Mr. Nelson and Mrs. Parks to look at revisiting the 59% and making the baseline better.
