Comment from Dr. Freeman. ACS has a financial issue. There has been an independent audit and a state audit of the finances. The surplus will run out in the spring of 2023 if it doesn't run out before. That is based on the historical spending pre-Covid. That is the fact.

Dr. Freeman recommended that the Board close the school and move Pre K to other buildings. Mr. Carter asked: What will happen to the building if the Board of Education approves the recommendation from Administration? Dr. Freeman responded that if the Board of Education chooses, the building can be used for the Maintenance Department and Child Nutrition. If the County Commissioners want to use the building for a Pre K hub they will need to support it financially.
