FINANCE

- Georgia Harvey and her team continue to work with Auditors for FY22 Financial Statements.
- Per the settlement, the taxing districts will provide HCA the following credit:

- The Asheville Middle School gym floor is complete!
- AerieHub is up and running. This is the district's hub for all blueprints. Emergency responders
 will be able to access this for safety and in case of an emergency.

CURRICULUM & INSTRUCTION

- Currently in the testing window for BOY Benchmarks. Schools will be diving into data to inform instruction.
- First late start this Wednesday, Sept. 21st; Elementary teachers will be working on LETRS and Secondary teachers will be working on core instructional problem solving together in PLCs.

- One-to-one devices have been distributed. Current 10th-12th graders kept their devices over the summer and we are pleased to see very low loss rates of devices.
- The AIG team has hosted two successful parent sessions about the new AIG plan and a third is being hosted tonight, September 19th, at Asheville Middle School.
- The application for year 3 of the 21st Century Community Learning Centers grant for elementary afterschool programs have been submitted.

OPERATIONS

- April Dockery and her team are working with MAHEC to get a flu shot and COVID booster pop-up clinic at each campus for interested staff. More information will be sent out soon.
- We continue to experience transportation issues with limited staffing causing adjustments and delays to bus routes. We have several new drivers currently in training but this takes time to complete. We continue to ask our parents to have patience with the situation.
- I am pleased to announce that Dillon Huffman has officially been named Asheville City Schools' new Public Information Officer. Dillon has worked in the Asheville City Schools communications/marketing department for the past 3 years. He will be working closely with April Dockery, our Executive Director of Operations.
