BE IT FURTHER RESOLVED that the Chester Board of Education hereby determines that the Student shall not be permitted to participate in any athletic, co-curricular and/or extra-curricular activities sponsored by the Chester Board of Education, and shall not be present for, or attend, any Chester Board of Education sponsored activities, either on Chester Board of Education premises or in any school district where the Chester School District is participating in the activities during the period of suspension; and

BE IT FURTHER RESOLVED that the suspension shall be reviewed at every subsequent regular board meeting to determine whether the suspension will be continued until the next regular board meeting; and

BE IT FURTHER RESOLVED that an alternate education shall continue to be provided to the Student during his/her suspension.
