**Board Goal Two: Student Learning Needs, Instruction and Assessment**

After an unprecedented period of disrupted schooling as a result of the COVID-19 pandemic, the Chester Board of Education will utilize our ESSER III funding for additional faculty members to assist in assessing the learning needs of our students through standardized state and in-house assessments to fully ascertain each student's learning needs in regard to remediation and acceleration. The faculty and administration will then plan accordingly to design instructional programs to meet those needs and keep all of our Chester students on the path to academic success. Progress will be continually monitored and shared with the community.

**Board Goal Three: School District Facilities, Health and Safety Standards**

WHEREAS, the Board has a need for a member of the middle school teaching staff to teach an extra class period, totaling seven (7) periods of instructional time per day three days per week (3.25 extra time periods); and

WHEREAS, Kathleen Vespignani, has expressed an interest in teaching an additional period; and

WHEREAS, the Board and the Union are desirous of entering into this Sidebar Agreement to permit Kathleen Vespignani, or other individual as assigned by the district, to teach an additional period.

NOW, THEREFORE the parties agree as follows:

1. Kathleen Vespignani, or other individual assigned by the District, shall be permitted to teach an additional period three days per week. For the extra period of instructional time, the employee so assigned shall receive a stipend of \$8,305.38.
2. The Parties recognize that this Agreement is temporary in nature and shall expire when the Board provides notice to the Union that it no longer desires to have Kathleen Vespignani teach an additional class period.
3. This agreement is subject to ratification by the Board of Education and the Union.
4. This agreement shall not be precedent setting in any way nor shall it be used in any other matter, grievance, or proceeding of any kind. This agreement is intended to apply only to the factual circumstances from which it arose and shall not have any precedential value.

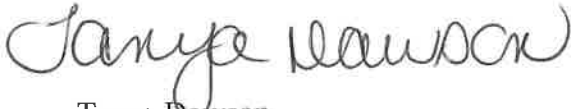
