WHEREAS, <u>N.J.S.A.</u> 18A:18B-1, <u>et seq.</u>, enables boards of education to join with other boards of education in school board insurance trusts for the purpose of forming self-insurance pools;

WHEREAS, the New Jersey Schools Insurance Group ("NJSIG") is a joint insurance fund authorized by N.J.S.A. 18A:18B-1, et seq. to provide insurance coverage and risk management services for its members;

11p. Approves Purchasing Agent for the 2024-2025 School Year

Resolved the Chester Board of Education, pursuant to N.J.S.A. 18A:18A-3 (a), designates Peter Frascella, School Business Administrator, Board Secretary, as the Qualified Purchasing Agent for the Board of Education and authorizes him to award contracts, in full accordance with the law, for purchases that do not exceed in the aggregate in a contract year the total sum of \$44,000.00 (bid threshold) without public advertising for bids. The Board of Education, pursuant to N.J.A.C. 5:34-8.3, et seq., further authorizes Peter Frascella to seek either competitive quotations or competitive bids when original determinations of aggregation are found to be more than anticipated or incorrect.

The manual outlines the proper purchasing practices that are to be followed by all Board of Education employees to be in compliance with the New Jersey State Law and Board of Education Policy.

The Public Agency Compliance Officer is responsible for administering contracting procedures pertaining to equal employment opportunity regarding the Chester Board of Education and the appropriate contracted vendors.

11s. Approves Cooperative Bidding Services

WHEREAS, the Chester Board of Education has the need, on a timely basis, to procure goods and services utilizing state contracts; and

WHEREAS, the Chester Board of Education desires to authorize its purchasing agent for the 2023-2024 school year to make any and all purchases necessary to meet the needs of the school district throughout the school year.

NOW THEREFORE BE IT RESOLVED, that Chester Board of Education does hereby authorize the District Purchasing Agent to make purchases of goods and services entered into on behalf of the State by the Division of Purchase and Property

11w. Approves HBCBSNJ and Delta Dental Plans Renewals

WHEREAS, the Chester Board of Education has determined an amount not to exceed \$1,200,000 may be available for such purpose of transfer;

NOW THEREFORE BE IT RESOLVED, that the Chester Board of Education hereby authorizes the district's School Business Administrator to make this transfer consistent with all applicable laws and regulations.
