- II. Public Comment
  - a. Ryan Farr: wishes to hear what the parents have to say about masks. Wants to discuss how difficult it is teaching young children while wearing masks. Its hard to see emotions and facial expressions and mask are hard to enforce
  - b. Carrie Devlin: No mandate, all the new info coming out about the effectiveness of cloth masks show they don't work. Should be a personal choice.
  - c. Kristin Trujillo: No mandate or make it classroom specific. Mask can negatively impact children's medical conditions. Asks for medical exemptions to opt out of masks in mandate stays in place.
  - d. Sandra Moore: In favor of masks for at least a few months.
  - e. Anne Sorensen: emailed in favor of lifting mandate.
  - f. Irene: No masks
  - g. Bernadette Fleming: In favor of lifting mandate but will respect any decision.

- i. Ms. Manuel: Should have some level of personal choice, and COVID is something we are going to be living with for a while.
- ii. Mr. Kamb: Reliability of date concerning kids and COVID numbers are probably skewed. Other districts stopping mandates and reviewed letter APS put out regarding dropping mandates and restrictions
- iii. Ms. Kirkbride: Not all kids have had the opportunity to get vaccinated yet, wants to wait a few months at least and maybe once it warms up and cold/flu season is over, and recesses/lunches are outside.
