The Civil Rights Movement

- 11.3 Explain the contributions of individuals and groups to the modern Civil Rights Movement (including Martin Luther King, Jr., James Meredith, Medgar Evers, Thurgood Marshall, Rosa Parks, Fannie Lou Hamer, the Southern Christian Leadership Conference (SCLC), the Student Nonviolent Coordinating Committee (SNCC), the Congress of Racial Equality (CORE), the National Association for the Advancement of Colored People (NAACP), and the grassroots efforts of the Civil Rights movement (civil rights foot soldiers).
- 11.4 Describe the development of the Black Power Movement (including the ideology of self-defense which inspired the change in focus of the SNCC, the rise of Malcolm X, Stokely Carmichael, and the Black Panther Movement).
- 11.5 Describe the significance of Martin Luther King Jr.’s “Letter from a Birmingham Jail” and his “I Have a Dream” speech.
- 11.6 Describe the accomplishments of the modern civil rights movement (including the growth of the African American middle class, increased political power, and declining rates of African American poverty).
- 11.7 Evaluate the effectiveness of major non-violent demonstrations and events on the Civil Rights Movement (including the Montgomery Bus Boycott, sit-ins, Freedom Rides, the March on Washington, and the Selma March).

Conservative Movement

12.3 Describe issues surrounding the changing global economy (including the North American Free Trade Agreement (NAFTA), immigration, national debt, technological trends, and global climate concerns).
