PURPOSE: To consider approving the bids and awarding the contracts for Child Nutrition milk/dairy products, bread, food, supplies, chemicals, ice cream, snacks, beverages and vending.

BACKGROUND: NC General Statue 143-129 governs the bidding process. All proposals shall be opened in public, the board shall award the contract to the lowest responsible bidder, taking into consideration quality, performance, and the time specified in the proposals for the performance of the contract.

Sealed bids from participating vendors were opened on May 16, 2011 in Raleigh. Eighty-seven (87) North Carolina LEAs formed a cooperative, the North Carolina Procurement Alliance, in order to take advantage of economies of scale and drive down the price of the child nutrition commodities (food, supplies, snacks, beverages, commodity storage, ice cream, and produce). The milk/dairy bid was opened on May 24, 2011. The apparent low bidders, which were reviewed and met specifications as outlined in the respective RFP's, are listed below:

Ice Cream and Frozen Fruit Products- Countryside Dairy Inc. (Renewal)

Beverage Vending- Canteen Vending Services (Renewal)
Beverages- Sysco Raleigh, Coca Cola and Pepsi Bottling of Roxboro
Produce- Layton's Produce (Renewal)

RECOMMENDATION: The Board approves the bids and awards the contracts to the apparent low bidders for the commodities noted on the Bid Tabulation Sheet.
