There shall be no standing committees of the Board.

Special committees may be appointed by the chairman when the need arises. Such committees shall be broadly representative of persons interested in and affected by the assignment of the committee. The function of special committees shall be fact-finding, deliberative, and advisory, but not legislative or administrative. Such committees shall serve until their purpose has been accomplished and/or until they are dissolved by the Board Chairman.

Every special committee shall render its report when due and when called for by the chairman. Any special committee failing to report as directed for two succeeding regular meetings shall be considered dissolved unless granted an extension by the Board.

The Board may form a committee of itself in order to study and work on special projects that may require considerable study and discussion.

School Board representation on other agency boards, and other assignments appropriate to the functions and needs of the Board will be determined by the chairman.
