This apportionment, in the amount of \$348,828, is made from federal funds provided to the state under Title III, Part A of the Elementary and Secondary Education Act of 1965, as amended by the Every Student Succeeds Act (Public Law 114–95). Title III, Part A English Learner funds are apportioned to local educational agencies (LEAs) to provide supplementary academic support and educational services to English learner students.
