This apportionment, in the amount of \$22,755,554, is made from federal funds provided to the state under Title I, Part A, of the Elementary and Secondary Education Act of 1965, as amended by the Every Student Succeeds Act (ESSA) (Public Law 114–95). Section 1003 of the ESSA provides grants to local educational agencies (LEAs) to serve schools implementing Comprehensive Support and Improvement (CSI) activities. Warrants will be mailed to each county treasurer approximately three weeks from the date of this letter.
