**Fourth Apportionment for Every Student Succeeds Act  
Comprehensive Support and Improvement  
County Offices of Education  
Plan Development and Implementation Subgrant  
Fiscal Year 2022–23**

This apportionment, in the amount of \$989,970.75 is made from federal funds provided to the state under Title I, Part A, of the Elementary and Secondary Education Act of 1965 (ESEA), as amended by the Every Student Succeeds Act (ESSA) (Public Law 114–95). The ESSA requires local educational agencies (LEAs) with schools eligible for comprehensive support and improvement (CSI) to locally develop and implement a CSI plan to improve student outcomes. The Budget Act of 2022 appropriates \$5 million to county offices of education (COEs) for CSI plan development and implementation support for LEAs in their county with schools eligible for CSI.

Only those COEs that submitted the 2022–23 ESSA CSI COE Plan Development and Implementation Support Application for Funding to the California Department of Education (CDE) are included in this apportionment. The amount paid to each COE is based on a formula that takes into consideration the total number of schools eligible for CSI, statewide.

Amounts paid in this apportionment are listed on the schedule of apportionment posted on the CDE Funding Results, ESSA Comprehensive Support and Improvement County Offices of Education Plan Development and Implementation Support, web page at <https://www.cde.ca.gov/fg/fo/r16/csicoefundingresults22.asp>. The CDE implements cash management pursuant to the cash management requirements under federal statute and regulations.

certifications, and terms and conditions of the subgrant are located in the 2022–23 ESSA CSI COE Plan Development and Implementation Support Application for Funding, which can be accessed on the CDE CSI COE Program Information web page at <https://www.cde.ca.gov/sp/sw/t1/csicoeproginformation21.asp>. The United States Department of Education (ED) grant award number for this funding is S010A220005 - 22A. The federal award date is July 1, 2022. The Catalog of Federal Domestic Assistance subprogram number is 84.010A (Title I, Part A, Basic Grants to Local Educational Agencies). The funding is appropriated in Schedule (1) of Item 6100-134-0890 of the Budget Act of 2022, AB 179 (Chapter 249, Statutes of 2022). The California sub-allocation (pass-through) number is Program Cost Account (PCA) 15439.

This subgrant is subject to the provisions of Title I and Title VIII, as applicable, of the ESEA, as amended by the ESSA, and the General Education Provisions Act (Public Law 103-382). This subgrant is also subject to Title I regulations in 34 *Code of Federal Regulations (CFR)*, Part 200, and the *Education Department General Administrative Regulations* in 34 *CFR*, parts 76 (except for 76.650–76.662, Participation of Students Enrolled in Private Schools), 77, 81, and 82, 2 *CFR* Part 3485, and the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards in 2 *CFR* Parts 200 and 3474.

The project period for the 2022–23 ESSA CSI COE Plan Development and Implementation Support subgrant begins on March 13, 2023, and ends on September 30, 2024. All fiscal year 2022–23 funds must be expended by September 30, 2024, and legally obligated within the dates designated and must not exceed the maximum amount allocated to the COE.

Pursuant to 2 *CFR*, Section 200.305(b)(9), interest earned amounts up to \$500 per year may be retained by the non-Federal entity for administrative expense. Any additional interest earned on Federal advance payments deposited in interest-bearing accounts must be remitted annually. COEs should forward interest payments for remittance to the ED to:
