This apportionment, in the amount of \$30,890,635.80, is made from federal funds provided to the state under Title I, Part A, of the Elementary and Secondary Education Act of 1965 (ESEA), as amended by the Every Student Succeeds Act (ESSA) (Public Law 114–95). Section 1003 of the ESSA provides grants to local educational agencies (LEAs) to serve schools implementing Comprehensive Support and Improvement (CSI) activities. Warrants will be mailed to each county treasurer approximately three weeks from the date of this letter.

Only those LEAs that reported expenditures in the Grant Management and Reporting Tool for the performance period February 1, 2022, to June 30, 2022, are included in this apportionment. Apportionments for each grant performance period are based on cumulative expenditures less prior cumulative payments, not to exceed each LEAs allocation.

County superintendents were notified of this apportionment by email sent to their CDEfisc email addresses. The CDE requests that the email be forwarded to all school districts and charter schools in the county that met the criteria for CSI.
