This apportionment, in the amount of \$147,404, is made from federal funds provided to the state under Title III, Part A of the Elementary and Secondary Education Act of 1965, as amended by the Every Student Succeeds Act (Public Law 114–95). Title III, Part A Immigrant Students funds are apportioned to local educational agencies (LEAs) to provide supplementary academic support and educational services to immigrant students.
