2024 - 2025 Transportation Registration

All reservations will be made on a first-come, first served basis. Students enrolled in ELC through 12th grade will be eligible for the bus service.

Central pick-up/drop-off points will be established prior to the beginning of the school year. Door-to-door service will not be provided. The routes will be designed to allow for an hour maximum length of travel. It may be necessary to refuse service in cases where time constraints cannot be met. **Transportation service will begin on the first day of classes.** Kindergarten students who are enrolled in The Heritage School Transportation Service will be permitted to use the Extended Care Program free of charge on the days they use the bus service. Please register your student for Extended Care services through our online registration link. A fee will be assessed if Extended Care is used on days students do not use our bus services.

Fees will be advance-billed on a school year, quarterly basis with no refunds or pro-rated charges available.

I understand that the bus driver will allow my child(ren) to remain on the bus while the driver continues the route and that my child(ren) will be returned to The Heritage School Care Program Facility. I further understand that I will be responsible for picking up my child(ren) at The Heritage School Extended Care program by 6:00pm and that I will be charged \$50.00 per child, per occurrence.

I understand and acknowledge that it is my responsibility to inform The Heritage School and my child(ren)'s bus driver in writing if there are any deviations from the above provisions and instructions.

I understand that The Heritage School reserves the right to deny bus service to any student.
