Student Representative George Carter suggested the high school either postpone having the SMART program until the 2021-22 school year if the program cannot be utilized both semesters during the 2020-21 school year. There have been no changes at the State level in regards to making high school Health Education an elective.

SMART - previously discussed.

For fourth grade, no changes are needed in the curriculum and will proceed with the normal Spring reproductive health education lessons. Fourth grade topics to cover include Topic 2 Changes in the Skin, Topic 3 Growing up Male (Day 2 of fifth grade), Topic 4 Growing up Female (Day 2 of fifth grade) and potentially incorporate all or some of Topic 5 (New Life) with Day 5 of fifth grade (Social/Emotional Changes). For fifth grade, there are a few GLCEs with missing background such as 7.2 Personal Hygiene, 7.1 Puberty Development and 7.7 Maintaining Personal Hygiene. Fifth grade topics to cover include Day 3 Reproduction, Day 4 Personal Hygiene Healthy Habits and Day 5 Social/Emotional Changes can be incorporated into Day 3 of sixth grade. For sixth grade, the GLCEs with missing background are 6.1-6.3 HIV/AIDS, 6.4 Health Behaviors and 7.5-7.9 Anatomy. For seventh grade, there are no gaps and topics to cover include Day 1 Gender Roles, Day 2 Everybody's Got Parts and Day 3 Reproduction Basics. For eighth grade, there are no GLCEs with missing background and all will be covered by the end of 8th grade. Day 2 of eighth grade HIV/STIs may be missing prior knowledge but the curriculum is robust enough that it may be covered with current eighth grade content. Nicole McGuire will discuss ninth through twelfth grade curriculum with the high school teachers.
