### HOW DO WE VERIFY RESIDENCE?

1. One Utility Proof (MUST be current) *NOTE: GAS BILLS NOT ACCEPTED*
  - Water monthly statement
  - Electric monthly statement
2. One Residence Proof (MUST be current)
  - Copy of Home Mortgage Bill
  - Current Apartment/House Lease
  - Copy of Section 8/HUD Housing Document
  - Copy of Home Sale Contract
  - Current HOA Bill
  - Current Tax Assessment Bill

**NOTE: We no longer accept the current Driver's License as a Proof of Residency**
