All regular meetings of the Board of Education will be held on Tuesday evenings commencing at 7:00 pm. Such regular meetings shall be held in the location as specified below unless the call for the meeting indicates a different time and/or location.

Such regular meetings shall be open to the public, and persons present shall be afforded an opportunity to address the Board of Education in accordance with the Open Meetings Act and subject to time limitations as established by the Board of Education.

In addition to the foregoing, the Board of Education of the Riverview Community School District shall provide for study sessions, and special meetings where a quorum of the Board is present for the purpose of either reviewing written reports of the administrators, and to audit and oversee the presentation of vouchers and supporting documentation; studying or reviewing technical or procedural details concerning operations of the schools, or operating equipment of the District or technical studies of proposed new programs; taking action on specific agenda items; or other matters preliminary to action at a regular Board meeting as requested by the Administrative Staff or Board of Education. Study Sessions of the Board of Education will generally be held on Monday evenings commencing at 6:30 P.M on the day before the Regular Meeting. These and any additional study

sessions or special meetings of the Board of Education will be held at the time, date, and location as indicated in the call for such meeting.

Such study sessions, or special meetings of the Board of Education shall be open to the public. Matters not germane to the work of the Trustees of the Board, concerning workshop or study sessions, shall be deferred to the next regular meeting and may not be addressed to the Trustees, except upon suspension of the rules by majority vote of the Board.

In the event that confidential matters shall require attention at any regular or special meeting, a closed session may be ordered upon roll call vote of the Board. In such instances, the closed session will be held as follows: Such closed session of the Board of Education shall not be open to the public and shall be deemed closed meetings of the Board of Education as permitted by Act 267, of P.A. 1976. Such closed session of the Board will be conducted in an appropriate room where confidentiality can be maintained in the building where the regular or special meeting is being held. Such closed session may be recessed to some hour later in the same evening if the work of the Board of Education requires, or if such is likely to encroach upon the 7:00 pm schedule of the formal meeting.

This Notice of Scheduled Meetings as herein recited is posted and filed as a matter of Public Record by the Secretary of the Board of Education, and at the direction of the Riverview Board of Education.

Proposed minutes of each of the meetings listed will be available for public inspection at the Riverview Board of Education office, 13425 Colvin St., not more than eight (8) business days after the date of said meeting, and approved minutes of each meeting will be available for public inspection at the same location and at www.riverviewschools.com/ not more than five (5) business days after the meeting at which the minutes are approved.
