SCHOOL BUS DRIVER

Part-time School Bus Driver:

Days/Hours: Monday thru Friday / 4-5 hours per day / hours may vary

Salary: \$145.48/day (after probation)

- Responsible for transporting students to and from school in a safe and timely manner. Keeps to assigned schedule only transporting authorized students and discharges students only at authorized stops.
- Maintains discipline when students are on the bus. Notifies supervisor of student discipline issues.
- Perform inspection of bus before and after each route. Maintain a clean bus at all times.
- Complies with all state and local laws when operating a school bus.
- High school diploma, GED, or equivalent experience required.
- Complete 20 hours of driver training, knowledge of Pennsylvania traffic laws, and the ability to operate 2-way radio.
- Ability to obtain Valid Pennsylvania Commercial Driver's License (CDL) to drive a school bus including 'S' and 'P' endorsements with air brake restriction lifted.
- Must possess outstanding oral and interpersonal skills.
- Ability to attend work regularly at assigned work hours.
- Performs other duties as assigned.
- Minimum of five (5) years of driving experience
