Dr. Thompson began with saying site visits have been conducted throughout the district the last two weeks saying he had seen the fruits of our staff's labor. Throughout the district he has seen a tremendous improvement in student's writing to explain, student independent work, and focused instruction truly aligned with the Kentucky Academic Standards. Dr. Thompson specifically wanted to recognize Mapleton, MSE, Northview, and McNabb for the noticeable strides that have been made and he expects to see good gains in the results of our current MVPA assessment, which is a great predictor for KSA at the end of the year. Dr. Thompson went on to say today, we began our collaboration with the Kentucky Center for Mathematics in order to strengthen our math instruction throughout the district. Just as our focus on, new materials, and intentional professional learning has given great gains in literacy, we know that we are moving on that same path for math.

Dr. Thompson shared that earlier this month we had three great collaborative opportunities with our community to benefit our students.
