



Brownwood ISD Meal Charge Policy

Brownwood ISD offers healthy meals every school day to all students at no cost. Typically, a student's household must meet income eligibility requirements to qualify for free or reduced meals. However, BISD participates in the "Universal Free Breakfast Mandate" and for SY 23-24 BISD will cover the cost for all student lunches. Students may charge for second meals, milk, juice, or extra entrée if the need arises. Brownwood ISD has a \$10 charge limit. If the student exceeds the limit efforts will be made to contact parents by a letter being sent home and a courtesy phone. Brownwood ISD accepts online payments through parentonline.net or Brownwoodisd.org. You must have your students ID number to set up an online account. Payments for meal accounts can be made at any campus cafeteria. It is not necessary to pay separately at each school. Payments can be entered from any of the BISD campus locations and/or at Brownwood ISD Administration Office

The Richard B. Russell National School Lunch Act requires the information on this application. You do not have to give the information, but if you do not, we cannot approve your child for free or reduced price meals. You must include the last four digits of the social security number of the adult household member who signs the application. The last four digits of the social security number is not required when you apply on behalf of a foster child or you list a Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF) Program or Food Distribution Program on Indian Reservations (FDPIR) case number or other FDPIR identifier for your child or when you indicate that the adult household member signing the application does not have a social security number. We will use your information to determine if your child is eligible for free or reduced price meals, and for administration and enforcement of the lunch and breakfast programs. We MAY share your eligibility information with education, health, and nutrition programs to help them evaluate, fund, or determine benefits for their programs, auditors for program reviews, and law enforcement officials to help them look into violations of program rules.
