As a parent/guardian or a student over the age of 18, you have the right to choose whether your/your child's directory information is released to military recruiters and/or institutions of higher education. **If you want to limit disclosures of your/your child's directory data to military recruiters and/or institutions of higher education, please check the appropriate choice(s) below and return this form to the school office no later than September 10, 2024, or within fourteen days following your/your child's enrollment in the District, whichever is later.** If you choose to opt out below, it will only apply for the 2024-25 school year or until the District issues the subsequent Opt Out Form, whichever is later. If you/your child graduates or withdraws from the District, the District will continue to honor the last opt out selection you made while you/your child attended the District unless you notify the District that your choice is rescinded and fill out the Request to Publish Directory Data Form.

#### "Opt Out" from Disclosure of Directory Information to Military Recruiters

Federal law requires the District to release the names, addresses, and telephone numbers of high school students to military recruiters who request this information unless the student's parent/guardian, or the student if over the age of 18, has directed the District not to release this information to military recruiters. #### "Opt Out" from Disclosure of Directory Information to Institutions of Higher Education

Federal law requires the District to release the name, address and telephone number of all high school students to institutions of higher education (such as colleges and universities) and state law requires the District to release the name and address of each such student who is expected to graduate from high school in the current school year unless the student's parent/guardian, or the student if over the age of 18, has directed the District not to release this information. #### "Opt Out" from Direct Admit Wisconsin

Direct Admit Wisconsin is an initiative by some Universities of Wisconsin to proactively offer admission to qualifying high school students between their junior and senior years. This removes the traditional application process and uses data provided by schools to admit students. The District's participation in Direct Admit Wisconsin allows the District to release student name, WISEid, student ID, graduation year, address, e-mail address, GPA, legal sex, and race/ethnicity. Demographic information is collected for aggregate federal reporting only, and is not a factor in direct admission decision process. If you **DO NOT** want the District to release this information to **Universities of Wisconsin**, please check the selection below.
