A \$5.00 Resident Per Capita Tax, taxable on 18 year olds and over based on Section 679 of the School Code of 1949. No change from 2002-2003.

- 1. Taxes under Act 511 with no changes from 2002-2003:
  - a. A 1% Earned Income Tax shared equally with the coterminous municipalities.
  - b. A 1% Realty Transfer Tax shared equally with the coterminous municipalities.
  - c. A \$5.00 Resident Per Capita Tax, taxable on 18 year olds and over.
  - d. A \$10.00 Occupational Privilege Tax.
