C. Lehigh Carbon Community College 2019-2020 Budget

Approve a resolution regarding the 2019-2020 Lehigh Carbon Community College Sponsor contribution Budget. Total expenditures equal \$6,186,337.00 which represents no change over the 2018-2019 budget.
