<u>Student Representatives to the Board Report</u> – Mr. Kemery and Ms. Hoffman verbally reported on the contents of the student representative report.

Superintendent's Report - Mr. Link presented a powerpoint on the 2019-2020 preliminary budget. The budget, as it stands, calls for a 3% tax increase and the district will utilize a portion of its fund balance to help offset a projected \$2.6 million budget shortfall. The district will continue to look for opportunities to decrease expenditures and/or increase revenues; and to utilize fund balance to cover additional deficit for the 2019-2020 budget. Mr. Kern asked what the median assessment was for each county. The median assessed value for Lehigh County is \$148,500, while the median assessed value for Northampton County is \$46,050. Mr. Link said at 3%, the annual tax increase on a median assessed home for Lehigh County is \$85, and for Northampton County \$96
